### **NEWS REPORT AUGUST 2024**

### **Monthly Highlights**

WNC is proposing to implement a 50-mph speed limit to replace the derestricted signs on the entrance to and exit from Little Houghton. The Consultation has now closed and WNC will proceed to final design, pricing and scheduling. On 31 July 2024, I asked Highways for an update on the status of the change P2023 to the Speed Limit on Bedford Road, Little Houghton.

On 17 July 2024, Sam Simons, Highway Service Manager wrote to Hartwell residents setting out the current position regarding the drainage works in the village of Hartwell.

The works outside the Old Rectory, Yardley Hastings 5381279 was completed on 2 July 2024.

I am still awaiting the pricing for surfacing and subsequent approval of Lodge Road, Little Houghton, which is to be completed during the Summer School break this year.

Part of Denton Road will be closed between 7-9 August 2024 to allow Anglian Water to undertake works to the main. They also intend to close Preston Deanery Road, Quinton between 19-21st August 2024.

Residents are invited to have their say on West Northamptonshire Council's (WNC) Draft Tenancy Strategy before midnight on Sunday 18 August 2024.

The Council would like to hear from anyone who has an interest in our parks and the development of a new strategy. The consultation will be live until midnight on 8 September 2024.

Please share your views on the Leisure Facilities in West Northants by completing the online survey in the Council's consultation hub before midnight on Sunday 15 September 2024.

If you think that there is not enough in the Local Transport Plan for you or your community then please respond to the consultation, which runs until 17 October 2024. If you do not submit your views then they cannot be considered.

Please visit the Have your say on the draft West Northamptonshire Electric Vehicles Infrastructure Strategy 2024-2030, which closes midnight Sunday 1 September 2024.

Please read through the WNC Annual Report to find out how we have performed during 2023/24.

There are still some cost-of-living roadshow events and pop-up stalls being held during August across West Northamptonshire to highlight the support available to residents.

As the Council undergoes a Revenue & Benefits Systems upgrade, the council tax, business rates and housing benefit systems will be temporarily unavailable from Tuesday, 13 August through to Thursday, 5 September. During the upgrade, residents will be unable to access the customer portal and online forms, though residents will be able to make council tax and business rates payments as usual. Ongoing benefits claims and regular payments will continue unaffected.

Adult Social Care Representatives will be at Welcoming Spaces, Towcester Library on 13 August 2024 from 10am – 12pm, no appointment is needed.

On 1 April 2024, the new housing allocation scheme came into place across West Northamptonshire replacing the three legacy schemes which operated in the Daventry, South Northamptonshire and Northampton areas. From Wednesday 14 August, residents will be able to see properties that fit their circumstances and make choices about which properties they are interested in through a Choice Based Lettings (CBL) system. Residents and stakeholders are invited to provide their input to an HMO Licencing Strategy by taking part in the survey via West Northamptonshire Council's consultation hub before midnight on Monday 7 October 2024.

Come along to Towcester Library on 14th August (1pm - 3pm) & access free help to find your dream job in West Northants.

Historic and cultural sites across Northamptonshire are invited to take part in this year's Heritage Open Days, which will take place between 6 and 15 September 2024.

The Northampton Balloon Festival takes place at Northampton Racecourse on Friday 16 to Sunday 18 August 2024.

Franklin's Gardens stadium has been announced as a venue for one of England's matches during the pool phase of the Women's Rugby World Cup 2025 tournament. It will host a Red Roses match during the 10th edition of the women's rugby event taking place across six weekends from 22 August to 27 September next year. Fans can register for free online to enter the presale on 24 September 2024 to ensure they are among the first to secure their place at the opening match and the final.

West Northamptonshire will welcome Britain's biggest professional cycle race this September, as we play host to the penultimate stage of the Lloyds Bank Tour of Britain Men. Taking place on Saturday 7 September 2024, the stage will start in Northampton town centre and take a 93-mile route through West Northants, before heading back to the finish line in Northampton.



### PARISH MEETINGS, VISITS AND CASEWORK

### Speed Limit Proposal for Bedford Road, Little Houghton, WNC Reference P2023

WNC is proposing to implement a 50-mph speed limit to replace the derestricted signs on the entrance to and exit from Little Houghton. The Consultation has now closed and WNC will proceed to final design, pricing and scheduling. On 31 July 2024, I asked Highways for an update on the status of the change to the





Speed Limit on Bedford Road, Little Houghton P2023.

### **Update on Drainage Issues in Hartwell**

On 17 July 2024, Sam Simons, Highway Service Manager wrote to residents setting out the current position regarding the drainage works in the village of Hartwell, details as follows: WNC have completed the following drainage works:

#### **Ashton Road:**

- Cleared the outfall of debris.
- Installed a pipe connecting Ashton Road to three gullies.
- Added a headwall by the allotments.
- Installed a catchpit to manage excess highway water during heavy rainfall.

#### **Amberley Road:**

- Replaced gully gratings to improve water flow.
- Addressed specific assets (Asset numbers 460130486, 460130485, and 460130484).

While some tasks remain outstanding, WNC believes they won't significantly affect the properties drainage. These include limescale management, pipe repairs, and vegetation clearing. There is also a ditch in the village that has, over time, been filled by vehicle accesses and hedgerow, if cleared this would take significant quantities of water that currently runs down the highway, WNC have no power to clear the hedgerow as we are not the owners. However, we plan to write to the owners to inform them of their obligations and the issues being caused.

In summary, we believe we have made substantial progress in alleviating the drainage issues where we can. However, if any flooding incidents occur during heavy rain, residents have been asked to call our emergency number, or provide a video or log of events leading to the flooding. Unfortunately, we cannot replicate flood events after the fact to identify any missed key elements.



### Little Houghton CE Primary School Garden 5 July 2024

On 5 July 2024, I was privileged to join many children and their parents at the Little Houghton CE Primary School Open Garden in aid of fund raising for the School Garden. The Children's enthusiasm together with that of their parents for this project was self-evident.



It was a pleasure to meet Lisa, Emma, Alice, Ralph and Mrs Carolyn Fairbrother, Headteacher and to thank them for their contribution to this school project. You can't but fail to be impressed with their combined passion for the school garden and the help they give children whilst learning about gardening.


On 15 July 2024, I escalated this Road Safety Issue. On 29 July 2024, I was advised that this matter has been fixed.

### Predisposition, predetermination or bias

As Chairman of the South Planning Committee, West Northamptonshire Council, I may be involved in the decision making for any subsequent planning application. Section 25 of the Localism Act 2011 provides that a decision maker is not to be taken to have had, or appeared to have had, a closed mind when making the decision just because:

- (a) the decision maker had previously done anything that directly or indirectly indicated what view the decision maker took, or would or might take, in relation to a matter; and
- (b) the matter was relevant to the decision.

This provision does not change the law on bias and pre-determination which means that Committee Members must still take planning decisions with an open mind and having considered all relevant material planning considerations. The safest course is for Committee Members to avoid making public statements (including expressing views in emails) as to their support for or opposition to any application which would indicate they had made up their minds before the formal consideration of the application at the meeting. If a Committee Member has made such a statement, they must be satisfied that they can still consider the application with an open mind and are prepared to consider any new matters or any new arguments in favour of or against the proposed development until the decision is made otherwise, they should not take part in any decision on the application in question.

On the grounds of the above, it would not be appropriate for me to attend Parish Council or Community events which seek to take a decision regarding the outcome of a planning application as I must keep an open mind on this matter so as not to preclude me from participating in any future planning decisions.

### **CONSULTATIONS**

A range of consultation and engagement activities are currently taking place across West Northants. I have summarised the main consultations below, but please remember you can check new consultations, have your say, and sign up to receive alerts and updates via our Consultation Hub.

### **Have Your Say on Draft Tenancy Strategy**

Residents are invited to have their say on West Northamptonshire Council's (WNC) Draft Tenancy Strategy which sets out the approach that Councils and Registered Providers of Social Housing need to consider when developing their own tenancy policies.

Every UK local authority is required by law to have a tenancy strategy outlining:

- The types of tenancies
- The circumstances that different types of tenancies will be granted
- The length of fixed-term tenancies
- The circumstances where a further tenancy can be granted following a fixed-term let

As well as aligning its objectives to support the Council's Corporate plan and key housing-related strategies, the draft West Northamptonshire Tenancy Strategy seeks to:

- Set clear expectations of all social registered providers operating across West Northamptonshire in tenancy related matters
- Highlight the Council's preferred approach to tenancy types offered
- Encourage social housing providers to offer greater tenancy support and tenancy sustainment
- Encourage social rent levels in new build homes

Once adopted, the Tenancy Strategy will replace the existing tenancy strategies currently in place in West Northamptonshire.

West Northamptonshire residents who hold a tenancy with a registered provider (otherwise known as a housing association), local tenant and resident groups, registered providers, and other interested parties and stakeholders are all encouraged to share their views in the survey.

People can take part in the survey by visiting the West Northamptonshire Council consultation hub before midnight on Sunday 18 August 2024.

### **West Northamptonshire Parks Development Strategy**

People are being asked to help shape a strategy setting out how West Northamptonshire Council (WNC)



manages and develops its parks and green spaces. The Council manages around 150 parks and green open spaces across West Northants, including war memorials, and town and country parks.

The new Parks Development Strategy will set out how the Council can protect, develop, and improve these areas in ways that not only enrich residents' and visitors' lives, but also the natural environment. The current version is very much in draft form as we are keen to engage with and hear the thoughts of park users, local businesses,



community groups and other stakeholders in order to shape the final document. The Council would like to hear from anyone who has an interest in our parks and the development of this strategy. The consultation will be live until midnight on 8 September. All responses will be analysed and considered by the Council in developing the draft strategy further. The feedback provided will help WNC to develop an updated version of the Parks Development Strategy and accompanying action plan. Once finalised, these will be presented to the Council's Cabinet in November 2024, with the final strategy to be published in 2025.

### **Local Transport Plan**

People are being encouraged to share their views on the development of our Local Transport Plan. The plan

has been developed with key stakeholders and details a range of

proposals for transport over the next 20 years, with the aim that by 2045 we will have worked with communities and partners to:

- 1) Make public transport more attractive and accessible
- 2) Make active travel such as walking or wheeling a first choice for short trips

If someone is unable to access the internet, they can also call the Council's customer services team from 9am to 5pm, Monday to Friday on 0300 126 7000 and speak to somebody directly about the support available.

#### **Upgrade to Revenue & Benefits Systems**

Residents can expect simplified and improved services through a major upgrade of our Revenue and Benefits systems. The upgrade replaces a number of legacy systems with a single, modern platform designed to simplify operations and improve the online experience. The new system will allow people to view all their benefits, council tax, business rates, and landlord accounts in one convenient portal. Business rates customers in Northampton will be able to access their accounts online and sign up for e-billing. This system upgrade will also introduce Daventry residents to a new online housing benefit form, simplifying the application process.

As the Council undergoes the upgrade, the council tax, business rates and housing benefit systems will be temporarily unavailable from Tuesday, 13 August through to Thursday, 5 September. During the upgrade, residents will be unable to access the customer portal and online forms, though residents will be able to make council tax and business rates payments as usual. Ongoing benefits claims and regular payments will continue unaffected.

However, new claims and notifications of change submitted during the close down will be assessed after the upgrade is complete.



While our customer service staff will still be available to support residents, their access to information will be limited. Residents are encouraged to contact us only for urgent matters during this time.

We appreciate everyone's understanding and cooperation as we work towards improving our services for the benefit of West Northamptonshire.

### **Housebuilding Planning & Growth**

In her first speech since being appointed Chancellor of the Exchequer, Rachel Reeves has outlined how growth will be achieved around the country through a raft of new measures. She has committed to the government delivering one and a half million new homes over the course of the next five years, thanks to a restoration of mandatory housebuilding targets. This number will include affordable and council homes. To support the delivery of the new homes, it was also announced that brownfield and greybelt land will be prioritised for development.

- Delivering 1.5 million new homes, including council and affordable housing
   Lifting the ban on onshore wind farms
   Supporting local authorities with
- 300 new planning officers
- Reviewing previously declined planning applications for projects that support the economy

Housing sites that have stalled are also to be accelerated through the creation of a new task force, with this process beginning for 14,000 new homes in areas including Liverpool Central Docks, Worcester, Northstowe, and Langley Sutton Coldfield.

Local authorities will be supported when it comes to planning, as a further 300 planning officers will be committed around the country. Alongside this, projects that will support the economy but have seen their planning applications declined will be reviewed – this work has already begun for the planning appeals for data centres in Buckinghamshire and Hertfordshire.

Further planning policy will be developed for critical infrastructure over the course of the coming months, whilst work to drive clean energy

development has been accelerated as the ban on onshore wind farms is lifted.

### **Housing Allocation Scheme**

On 1 April 2024, the new housing allocation scheme came into place across West Northamptonshire replacing the three legacy schemes which operated in the Daventry, South Northamptonshire and Northampton areas. From Wednesday 14 August, residents will be able to see properties that fit their circumstances and

We aim to complete the assessment within 33 working days, however this can take longer when demand is high. Please do not call us to chase on the progress of your application as this may delay the process further.

make choices about which properties they are interested in through a Choice Based Lettings (CBL) system. This is the system that was previously used in the Northampton area.

CBL works through a bidding and points system, with housing providers uploading adverts based on attributes requested in the online application forms, and applicants who are live in the system placing a bid on the properties they think are suitable for them as part of a weekly cycle. Once the bidding cycle is closed to applicants, the property is offered to the applicant that is highest on the priority list. If that person rejects the home, it will be offered to the next person on the priority list, and so on. Homeless individuals tend to be high on the priority list to ensure they are housed quickly.

### **HMO Licensing Consultation**

West Northamptonshire Council (WNC) is seeking residents' views on a new proposed licensing scheme which includes additional licensing areas for homes in multiple occupation (HMOs).

A HMO is a property where more than 3 people that form more than one household, rent a home, and

share some facilities such as the kitchen or a bathroom in the home with the other tenants. HMOs can include:

- a house let as individual bed-sitting rooms
- a group of rooms on each floor let to single occupants
- hostels, some hotels and guesthouses
- lodgings and shared houses
- houses converted into self-contained flats

The new scheme will be a continuation of the existing



scheme introduced in 2020, but extended to include areas of new development, areas where the level of

anti-social behaviour or property conditions indicate that further intervention is necessary, and to bring a closer alignment of the Additional Licensing designation to the Council's Article 4 restrictions under the Town and Country Planning Act.

A street list and map of the existing areas and proposed additional licensing areas can be viewed in the consultation documents.

Landlords in the enhanced designated area will need to apply for a HMO licence, failure to do so could result in conviction and an unlimited fine through the courts or a civil penalty of up to £30,000 through the Council's powers under the Housing and Planning Act 2016.

They might also have to pay back up to a year's rent to either the tenant, or the Council in the case of Housing Benefit, if a rent repayment order is applied for.

The current Additional HMO Licensing scheme ends on 31 January 2025 and, if approved, the new additional five-year scheme will come into effect as soon as possible after 1 February 2025.

The 10-week consultation aims to gather residents' thoughts on these proposals as well as input on how to improve housing standards and ensure safe, well-maintained accommodation for everyone.

WNC's Cabinet will consider a report on the proposed scheme, including results from the consultation, at its meeting in November 2024. ### **ENVIRONMENT**

### **Bird Keepers Urged to Register their Flock**

West Northamptonshire Trading Standards Team are urging everyone who keeps poultry or captive birds to



register with the Animal and Plant Health Agency (APHA). Currently, anyone who keeps 50 or more birds it is compulsory to register their flock, however, those with fewer birds can voluntarily register. From 1 October, new requirements for all bird keepers who keep their poultry outdoors - regardless of the size of their flock – will come in which will require any who owns captive birds or poultry must officially register their birds. The new rules cover owners of backyard flocks, birds of prey and pigeon fanciers, but do not affect caged pet birds (excluding any poultry species) kept entirely inside a domestic dwelling,

such as a parrot, canary or budgie, which never leaves the property other than to visit a vet or another short-term period.

By registering their birds, keepers will ensure they receive important updates relevant to them, such as on any local avian disease outbreaks and information on biosecurity rules to help protect their flocks. This will help to manage potential disease outbreaks, such as avian influenza and Newcastle disease, and limit any spread. It also enables them to keep up to date with the latest national and regional guidance.

### **New Strategy for Nature Recovery**

WNC is in the process of developing a Local Nature Recovery Strategy for the area. This is one of many tools coming out of The Environment Bill 2021 to deliver the government's Environment Improvement Plan (EIP). The Strategy will identify where the best places are to recover nature and deliver wider environmental



benefits in the authority area. It will guide and focus funding on these areas through other EIP tools such as Biodiversity Net Gain and government grants.

Since March, Nene Rivers Trust has been working on our behalf to engage stakeholders including landowners and the public. From mid-July onwards, now that the evidence and mapping data has been compiled, and the priorities and potential measures have been collected from stakeholders, the strategy will start taking shape. Following approval from Natural England and the Council ELT, a draft strategy will be due for public consultation in mid-October for a 6-week period. Bradlaugh Fields has retained the award for the fifth year running and Abington and Delapre parks, also in Northampton, retain their awards for the eleventh and twelfth years in a row respectively, in recognition of the hard work of community groups and volunteers to maintain these widely

used open spaces. Daventry Country Park, which has seen improvements to its visitor facilities in recent years, achieves the award for the 25th time.

The Green Health at Daventry project was also successful in achieving the Green Flag Community Award for its community garden, which is run with support from Daventry Country Park's Rangers. Our green spaces are essential to our residents' wellbeing and provide vital environmental benefits for local wildlife. These

awards recognise the brilliant work that our park rangers, community groups, volunteers, and residents continue to do to maintain and improve our open spaces.

To find this out they have created a survey, which should take a maximum of 10 minutes to complete. The questions cover topics such as how you feel about your own health and what works best for you in managing both your mental and physical wellbeing.

Once they have collected all the responses, a report will be created – providing recommendations for local authorities and health services based on the feedback from everyone in Northamptonshire.

### **New Adult Social Care System**

West Northamptonshire Council has signed a new five-year contract with social care software specialist, System C, to implement its Liquidlogic case management application for adult social care in the region.

The new cloud-based system is due to go live in February 2025, offering an integrated, comprehensive single view of individuals. It will incorporate a person's GP data and provide residents with the ability to manage their own records through a dedicated customer-facing portal.

Once live, the solution will be used daily by a council workforce of over 500 staff providing complex care and support to over 4,500 residents. More widely it will also be accessed by other users including social care providers, carers, and the voluntary sector. The new case management application will include a fully integrated finance system with the key benefit of streamlining assessment and payment processes. This integration will enable the council to enhance efficiencies and take a proactive approach in



managing referrals for individuals requiring adult social care services. For residents, it will provide a dedicated portal where they can manage their account from one simple login, providing improved access for self-managing their records.

Thank you for your enquiries regarding the steps WNC has taken to ensure the confidentiality of people's medical records once the Liquid Logic system goes live. I have been advised that Shared Care Record functionality will be available for use with the new Liquid Logic solution however it will be part of the LA's Phase 2 programme. The LA will work with the supplier to fully understand its functionality and governance arrangements before switching this on to operational teams. ASC will work closely with the information governance team to ensure compliance in relation to consent and safe practices. I am happy to provide a more detailed response once ASC are clearer on the approaches open to us to consider. Once I have further news, I shall be in touch.

Our Council has launched a new online resource focused on providing families with a wealth of resources and local service information. The Family Hubs website provides bespoke guidance to cater to the needs of families at every life stage; from conception and pregnancy, through to toddlers, school admissions and the teenage years. It offers a seamless experience, organising information by age range to facilitate easy access to relevant support.



The website provides comprehensive guidance and local service details tailored to meet the specific needs of the local community, whether they're expecting a child, raising a toddler, or navigating the teenage years. Currently in its initial phase, the Family Hubs website is set to evolve further with the addition of new features and expanded content over the coming months. We are also working closely with community organisations and partners to look at how it can extend this

offer across all nine of our Local Area Partnerships (LAPs) in West Northants.

We are committed to continually enhancing this resource to better serve the community, ensuring families have access to up-to-date and pertinent information. #### Reminder for Children to be Vaccinated

#### **Yellow Heat Health Alert**

A Yellow Heat-Health Alert was issued across the East Midlands from 29 July to Wednesday 31 July by the UK Health Security Agency (UKHSA) and the Met Office. The warmer weather poses a much greater risk to the most vulnerable in our community, such as the very young and older people.

Residents are advised to remain cautious and seek advice from 111 if non-emergency health advice is required. 999 services should be used in emergencies only. The top ways for staying safe in the heat are to:

- 1) Look out for those who may struggle to keep themselves cool and hydrated; older people, those with underlying conditions and those who live alone are particularly at risk.
- 2) Close curtains on rooms that face the sun to keep indoor spaces cooler and remember it may be cooler outdoors than indoors.
- 3) Use cool spaces if going outdoors.
- 4) Drink plenty of fluids and avoid excess alcohol.
- 5) Never leave anyone in a closed, parked vehicle, especially infants, young children, vulnerable adults, or animals.
- 6) Try to keep out of the sun between 11am to 3pm, when the UV rays are strongest.
- 7) If you have to go outside in the heat, walk in the shade, apply sunscreen and wear a wide-brimmed hat.
- 8) Avoid physical exertion during the hottest parts of the day.
- 9) Make sure you take water with you if you are travelling.
- 10) Stay up to date with by visiting our hot weather web pages.



### StaySafe4Summer Campaign

As the school summer holidays get underway, children in Northampton are benefitting from safety advice thanks to a neighbourhood Police Community Support Officer (PCSO). The <u>#StaySafe4Summer</u> campaign is run annually by Northamptonshire Police PCSO Naomi Coote to share potentially life-saving advice with primary school-age children across her Northampton Central patch.

Naomi organised sessions for children in Years 5 and 6 in 10 schools in the run-up to the holidays, working



with partners including Northamptonshire Fire and Rescue Service (NFRS), the joint police and fire service Arson Task Force, London Northwestern Railway, South Northants Community Responders and West Northamptonshire Council.

Topics in the assemblies included water safety, the dangers of setting fires, railway safety, basic first aid and staying safe when out and about in the summer sun.

Part of Naomi's work included a safety superhero poster competition for Year 5

pupils supported by funding from the Office of the Police, Fire and Crime Commissioner. On Saturday, 20 July 2024 the winners were announced at an event in the Grosvenor Centre which saw representatives from Northamptonshire Police, NFRS, the Arson Task Force, Crimestoppers, Re-Solve, South Northants Community Responders and Northamptonshire Emergency Service Cadets share advice with families and shoppers.

The competition winners were Brooke Lowe from Earl Spencer Primary School was picked for her Super Sky character, alongside Maryama from Spring Lane Primary School, who created Sunny Summer to share safety advice.

As well as prizes including Amazon vouchers donated by the OPFCC and London Northwestern train tickets,

their superhero designs have been made into safety advice leaflets which will be handed out at events over the summer, with the designs from the runners up set to go on display at the PFCC's office in Wellingborough.

#### **ACRE Reopens Grants for Village Hall Improvements**

ACRE is pleased to confirm that village hall management committees can apply once again for larger grants to improve their buildings. The fund, which was originally announced to mark the Late Queen's Platinum Jubilee has reopened for new applications.



Groups can submit applications for grants of between £7,500 and £75,000 which can be used to cover up to 20% of capital costs associated with renovation and improvement projects. This latest window for new applications is expected to last until government funding has been exhausted. The process is competitive and hall committees must be able to complete the project work by the end of March 2025. #### **Additional Highways Investment**

An additional £10 million will be invested into improving roads across West Northamptonshire. The extra funding will allow WNC and its highways partner Kier to extend the surface dressing programme for roads and paths across the area as well as carrying out bridge maintenance schemes



and work to resolve drainage issues across the area. This will also provide the opportunity to trial an innovative road surfacing technique (called in-situ recycling) that produces a long-lasting repair and reuses existing material to reduce costs and carbon emissions, resulting in more sustainable repairs across our rural network.

The additional funding, which was approved at Council on Thursday 18 July 2024 is coming from the capital budget which is used for things like improving local infrastructure. This follows on from the £2.8 million investment into purchasing and operating new machinery in 2023, which has already increased the efficiency of road maintenance and repairs in our area.





### Closure Order at Northampton Property Following Drug Related Anti-Social Behaviour

A property in Northampton has been issued with a full closure order following concerns around drug dealing and anti-social behaviour from members of the public. The 3-month order follows numerous complaints from local residents about a range of disruptive activities linked to the flat, located in Park Avenue in Abington, over the past six months.

Since January 2024, there have been persistent



On 10 July 2024, West Northamptonshire Council's (WNC) Anti-Social Behaviour team and Northamptonshire Police successfully obtained a closure order to shut down the property under Part 4 of the Anti-Social Behaviour, Crime and Policing Act 2014. The Council and the police worked together to

gather the evidence needed to obtain the closure order at Northampton Magistrates Court. The property will be secured and boarded to prevent entry. Any unauthorised person who enters the property will be committing a criminal offence.

Closure orders last for a period of 3 months and can be extended further if necessary. They are used when other approaches to tackling anti-social behaviour have been unsuccessful and aim to protect residents living in the neighbourhood by preventing criminal behaviour taking place in or around a property. If you are experiencing issues with anti-social behaviour or suspected criminality where you live, please report it to police on 101 or report online at <a href="https://www.northants.police.uk/RO">www.northants.police.uk/RO</a>. In an emergency, where a crime is in progress or life is at risk, always call 999.

### **Ten-Second Triage Kits added to Fire Appliances**

New kit is being added to all frontline Fire appliances in Northamptonshire to help firefighters speed up the



triage of injured patients at major incidents. All fire engines will have tensecond triage kits, which allow fire crews to identify what category of care an injured patient needs within ten seconds and put a colour coded wristband on that quickly identifies to paramedics which patients need urgent care. The kit has been purchased following the findings of the Manchester Arena

inquiry, and it will allow all emergency responders — whether that's Fire, Police or Ambulance — to start to be able to rapidly triage patients and mark what priority of care they will need at major

and critical incidents. Xtract Stretchers will also be added to all frontline

appliances, and this will allow fire crews to be able to quickly move people away from areas of risk.





Franklin's Gardens stadium has been announced as a venue for one of England's matches during the pool phase of the Women's Rugby World Cup 2025 tournament. The 15,000 capacity stadium - home of course

to the Premiership champions Northampton Saints - will host a Red Roses match during the 10th edition of the pinnacle women's rugby event taking place across six weekends from 22 August to 27 September next year. The full match schedule and kick-off times will be announced in October, when fans will be able to buy tickets for what promises to be the biggest-ever global celebration of women's rugby.



It will be a chance to watch the world's 16 best teams

and the biggest stars of the game compete at eight locations across the length and breadth of the country, culminating in a grand finale at Twickenham Stadium. Ticket prices will range from £5 to £95 across the tournament, with over 60 per cent of tickets under £25 and children's prices available at every match. Accessible tickets will also be available for all matches.

Fans can register for free online to enter the presale on 24 September 2024 to ensure they are among the first to secure their place at the opening match and the final.

September, the stage will start in Northampton town centre and take a 93-mile route through West Northants, before heading back to the finish line in Northampton. This area is no stranger to professional cycling, having held women's Tours of Britain in 2014 and 2016, but this will mark the first occasion that the men's event has come to the county. Events like this play an important role in bringing communities together and inspiring people to take up sport and live a more active and healthier lifestyle. They also provide a significant

#### **Car Park Dig**

Archaeologists working at Chalk Lane discovered large pieces of ironstone which may once have formed part of Northampton Castle. They were revealed by experts from the Museum of London Archaeology

(MOLA) during an initial investigation of the car park, ahead of its transformation to deliver a new heritage park for Northampton. Situated near the entrance to the railway station, this scheme will create an attractive green space in one of the town centre's key gateways, offering a playground and community garden, together with a series of timeline poles revealing the area's rich history. The dig, which took place earlier this month, revealed several large pieces of ironstone, likely quarried in



Northamptonshire and which may relate to the demolition of Northampton castle in 1879. This ironstone was mixed with brick and modern pottery and located next to trenches dug by archaeologists in the 1960s, suggesting it is the remains of the rubble they removed. MOLA's investigations also revealed the remains of a post medieval wall belonging to a house built amid the ruins of the castle. This work, along with other excavations in the town centre, is helping build an understanding of how the town developed around the castle in the centuries following the Civil War, when its defences were removed. Motorists are reminded Northampton's Chalk Lane Car Park will remain closed until 12 August 2024 while work takes place to return the car park to a safe standard so it can reopen.
