# **NEWS REPORT SEPTEMBER 2024**

### **Monthly Highlights**

WNC is proposing to implement a 50-mph speed limit to replace the national speed limit on the access to and from Bedford Road, Little Houghton. WNC will proceed to final design, pricing and scheduling. Once I have a date for the works, I will let you know.

Cogenhoe & Whiston Parish Council extended the Village Hopper to Weston Favell, Wellingborough (daily rather than just Saturdays), Rushden Lakes & Stanwick Lakes (Saturday & school holidays only. The minibus runs like a regular bus service with a set timetable with journeys between 7:30am and 6pm several times a day from Monday to Saturday to help residents travel to work, college, the shops and Northampton General Hospital.

On 30 August 2024, Kier Transportation, working together with West Northamptonshire Council, carried out work in Lodge Road, Little Houghton. I am pleased to let you know that the feedback from the residents has been excellent with comments like 'great organisation' and 'awesome job'.

Highways have advised me that temporary traffic works are in place on the A428 to reduce stress on a failing structure, which is described as 'parapet repairs'. They are working at planning repairs, but they are complex. The two- way traffic signals will remain in place as a 24-hour safety measure until the works are completed which is not likely until the end of September 2024. Once I have further news, I shall be in touch.

I have been informed that works on the Causeway Bridge, Billing will take place from 2 to 4 September 2024.

The Council would like to hear from anyone who has an interest in our parks and the development of this strategy. The consultation will be live until midnight on 8 September 2024.

Please share your views on the Leisure Facilities in West Northants by completing the online survey in the Council's consultation hub before midnight on Sunday 15 September 2024.

If you think that there is not enough in the Local Transport Plan for you or your community then please respond to the consultation, which runs until 17 October 2024.

Please visit the 'Give us your views on Pharmaceutical Needs' Consultation, which closes midnight Sunday 6 October 2024.

Residents and stakeholders are invited to provide their input to an HMO Licencing Strategy by taking part in the survey via West Northamptonshire Council's consultation hub before midnight on Monday 7 October.

The fifth round of the Household Support Fund has been announced and funded by UK Government until the end of September 2024. See my Monthly Report.

Adult Social Care will be at Welcoming Spaces, Towcester Library on 10 September 2024 from 10am – 12pm, no appointment is needed.

The final recommendations arising from the Community Governance Review for West Northamptonshire have been published on our website. See my Monthly Report.

MHCLG launched a consultation seeking views on proposed reforms to the National Planning Policy Framework and other changes to the system, which is open now and will close at 11.45pm on Tuesday 24 September 2024.

WNC has approved a capital budget of £12.372 million to provide relocatable temporary accommodation as part of our ongoing efforts to address the rising need for temporary housing in the area. See my Monthly Report.

Organisations wishing to join our network of Welcoming Spaces are being offered grants of up to £1,500 to help them set up a Welcoming Space.

West Northamptonshire Council (WNC) has awarded £1.4 million in grant funding to a wide range of projects, including 24 community organisations to support initiatives focused on enhancing local skills, addressing critical needs, and fostering positive change within the community. Our new Community Mental Health Prevention Grant allows people to bid for funding for collaborative projects to tackle mental health inequalities within our local area. Organisations must submit an expression of interest by 27 September 2024. See my Monthly Report.

Historic and cultural sites across Northamptonshire are invited to take part in this year's Heritage Open Days, which will take place between 6 and 15 September 2024.

Franklin's Gardens stadium has been announced as a venue for one of England's matches during the pool phase of the Women's Rugby World Cup 2025 tournament. It will host a Red Roses match during the 10th edition of the women's rugby event taking place across six weekends from 22 August to 27 September next year. Fans can register for free online to enter the presale on 24 September to ensure they are among the first to secure their place at the opening match and the final.

Team GB Olympic gold medallist Tom Pidcock is set to be among the riders when the Lloyds Bank Tour of Britain cycling race visits West Northamptonshire on Saturday 7 September 2024. See my Monthly Report.



### Fix My Street Little Houghton 5869001

On 12 May 2024, I received a further complaint



regarding the A428 and the slip road into Little Houghton. Residents are concerned about the current sight line which is masked by vegetation overgrowth and is making the junction to and from the A428 dangerous. As it is a Highway

Safety issue, have escalated the matter

to Highways, and I am asking that this item be resolved before October 22nd, 2024, which is unreasonable in the circumstances that it has been outstanding since early May


2024. I have since heard that the defect meets the requirement for a Priority 4 repair and the current average response time for a Priority 4 repair is 37.3 days.

### Fix My Street Cogenhoe 6107432

I escalated 6107432 on 17 July 2024 and I was advised that they were currently awaiting a Greens Report. I have chased them again on 29 August 2024. Once I have further news, I shall be in touch.

### Fix My Street Cogenhoe 6165526

On 31 July 2024, I escalated the matter of the roadway being reduced by up to 1 metre by overgrown trees/bushes as a matter of road safety. I was advised by Highways that this doesn't meet their criteria for urgent works. They also said that 'often we see defects of this kind being completed within 39 days'. Once I have further news, I shall be in touch.



#### Predisposition, predetermination or bias

As Chairman of the South Planning Committee, West Northamptonshire Council, I may be involved in the decision making for any subsequent planning application. Section 25 of the Localism Act 2011 provides that a decision maker is not to be taken to have had, or appeared to have had, a closed mind when making the decision just because:

- (a) the decision maker had previously done anything that directly or indirectly indicated what view the decision maker took, or would or might take, in relation to a matter; and
- (b) the matter was relevant to the decision.

This provision does not change the law on bias and pre-determination which means that Committee Members must still take planning decisions with an open mind and having considered all relevant material planning considerations. The safest course is for Committee Members to avoid making public statements

(including expressing views in emails) as to their support for or opposition to any application which would indicate they had made up their minds before the formal consideration of the application at the meeting. If a Committee Member has made such a statement, they must be satisfied that they can still consider the application with an open mind and are prepared to consider any new matters or any new arguments in favour of or against the proposed development until the decision is made otherwise, they should not take part in any decision on the application in question.

On the grounds of the above, it would not be appropriate for me to attend Parish Council or Community events which seek to take a decision regarding the outcome of a planning application as I must keep an open mind on this matter so as not to preclude me from participating in any future planning decisions.

# **CONSULTATIONS**

### **West Northamptonshire Parks Development Strategy**

People are being asked to help shape a strategy setting out how West Northamptonshire Council (WNC)



manages and develops its parks and green spaces. The Council manages around 150 parks and green open spaces across West Northants, including war memorials, and town and country parks.

The new Parks Development Strategy will set out how the Council can protect, develop, and improve these areas in ways that not only enrich residents' and visitors' lives, but also the natural environment. The current version is very much in draft form as we are keen to engage with and hear the thoughts of park users, local businesses,

community groups and other stakeholders to shape the final document. The Council would like to hear from anyone who has an interest in our parks and the development of this strategy. The consultation will be live until midnight on 8 September. Click here to view the draft strategy and have your say.

All responses will be analysed and considered by the Council in developing the draft strategy further. The feedback provided will help WNC to develop an updated version of the Parks Development Strategy and accompanying action plan. Once finalised, these will be presented to the Council's Cabinet in November 2024, with the final strategy to be published in 2025.

### **Consultation to Lower Age of Hunsbury Park School**

We are looking for views on the proposal to lower the age range for Hunsbury Park Primary School, Dayrell Rd, Northampton NN4 9RR from ages 4- to 11-year-olds to 2- to 11-year-olds. This will allow Hunsbury Park Primary School to take over the running of Campers Early Years and Out of School Club, located on site at Hunsbury Park Primary School (that is currently closed due to unforeseen circumstances).



Consultation on the Proposal to lower the age range at Hunsbury Park Primary School, Northampton

It is proposed that subject to a successful consultation process and statutory approvals being granted the nursery will re-open from Monday 23 September 2024. This will bridge the gap in provision for 2- to 11-year-olds in the local area and ensure continuity of service for families and the community. Hunsbury Park Primary School propose to continue running the previous term time, full day care model, offering flexible patterns to meet the needs of the working demographic. They will operate between 8am and 5:30pm, Monday to Friday and will continue to offer 24 full time equivalent funded early education entitlement (FEEE) places to 2- to 4-year-old children and an out of school club for 4 to 11 years.

To support a robust handover and to meet staffing requirements, they will be providing a staged approach by offering pre-school (3-year-olds) morning and afternoon sessions in the first academic year (2024/25) and extended full nursery sessions to 2- and 3-year-olds in the second academic year (2025/26). Although the school are proposing a staged approach, it is expected to have a minimal impact on families due to the low number of 2-year-olds previously in attendance.

Under this proposal, children aged 2-4 years would formally become part of the same structure as the school within the nursery school provision and on the nursery roll. The changes proposed are expected to be permanent. West Northamptonshire Council (WNC) is responsible for delivering early years provision within the Hunsbury area of West Northamptonshire. It is also legally obliged to conduct a period of consultation on this proposal as part of the statutory decision-making process.

Children will benefit from one cohesive team working with the school's early years cohort and a high-quality teaching and learning experience with provision led by the Head of Early Years (QTS).

All responses must be received by midnight on Tuesday 10 September 2024.

We would also like to know how residents feel about the Council's leisure centres, the facilities themselves, the activities that go on in the centres and the priorities for the centres moving forward.


Responses will help us to understand the needs of people in West Northants and develop an Active Lives Strategy which considers future leisure centre management.



### **HMO Licensing Consultation**

West Northamptonshire Council (WNC) is seeking residents' views on a new proposed licensing scheme which includes additional licensing areas for homes in multiple occupation (HMOs).

An HMO is a property where more than 3 people that form more than one household, rent a home, and share some facilities such as the kitchen or a bathroom in the home with the other tenants.



- a house let as individual bed-sitting rooms.
- a group of rooms on each floor let to single occupants.
- hostels, some hotels and guesthouses.
- · lodgings and shared houses
- houses converted into self-contained flats.

The new scheme will be a continuation of the existing scheme introduced in 2020, but extended to include areas of new development, areas where the level of anti-social behaviour or property conditions indicate that further intervention is necessary, and to bring a closer alignment of the Additional Licensing designation to the Council's Article 4 restrictions under the Town and Country Planning Act.

A street list and map of the existing areas and proposed additional licensing areas can be viewed in the consultation documents.

Landlords in the enhanced designated area will need to apply for a HMO licence, failure to do so could result in conviction and an unlimited fine through the courts or a civil penalty of up to £30,000 through the Council's powers under the Housing and Planning Act 2016.

They might also have to pay back up to a year's rent to either the tenant, or the Council in the case of Housing Benefit, if a rent repayment order is applied for.

The current Additional HMO Licensing scheme ends on 31 January 2025 and, if approved, the new additional five-year scheme will come into effect as soon as possible after 1 February 2025.

The 10-week consultation aims to gather residents' thoughts on these proposals as well as input on how to improve housing standards and ensure safe, well-maintained accommodation for everyone.

WNC's Cabinet will consider a report on the proposed scheme, including results from the consultation, at its meeting in November 2024. We are keen for residents, businesses, community groups, landowners, and other stakeholders to have their say on whether they agree with the proposals in the plan and help shape the future of local transport across the county.

### **Household Support Fund**

The fifth round of the Household Support Fund has been announced and funded by UK Government until the end of September 2024. West Northamptonshire Councillors have approved plans for distributing this funding in line with the Government guidance. This includes:

- providing around 12,700 families with children on benefits related free school meals with vouchers over the summer holidays for food and school essentials such as uniforms,
- providing grants to voluntary and community organisations allowing them to increase the dedicated and tailored support that they offer to residents,
- continuing to collaborate closely with our trusted partners to provide tailored support to residents with:
  - debt and money advice
  - energy saving advice.
  - practical energy saving measures.
  - practical household support

All awards and funding are complimented by wrap around support schemes to help transition households from crisis support to more sustainable longer-term offer of financial wellbeing.

### Pupils in receipt of benefits-related free school meals

Voucher links providing support for both Spring Term School Holidays were issued in March and May 2024 to all eligible pupils. These links have now expired and cannot be backdated.

Grocery vouchers have now been issued to schools or parents/carers of all pupils in receipt of benefits related free school meals. These are valued at £15 per child, per week of the summer holiday (some schools are eligible for 6 weeks, and some are eligible for 5 weeks).

A further £30 School Essentials voucher has also been issued to support with the purchase of school uniform, shoes, stationery or books.

#### Support where you live.

Local Voluntary and Community Organisations have been able to apply for grants funded by the Household Support Fund. This allows them to use their knowledge and understanding of the needs of residents to provide tailored support.

#### **Upgrade to Revenue & Benefits Systems**

Residents can expect simplified and improved services through a major upgrade of our Revenue and Benefits systems. The upgrade replaces several legacy systems with a single, modern platform designed to simplify operations and improve the online experience. The new system will allow people to view all their benefits, council tax, business rates, and landlord accounts in one convenient portal. Business rates customers in Northampton will be able to access their accounts online and sign up for e-billing. This

system upgrade will also introduce Daventry residents to a new online housing benefit form, simplifying the application process.

As the Council undergoes the upgrade, the council tax, business rates and housing benefit systems will be



temporarily unavailable from Tuesday, 13 August through to Thursday, 5 September. During the upgrade, residents will be unable to access the customer portal and online forms, though residents will be able to make council tax and business rates payments as usual. Ongoing benefits claims and regular payments will continue unaffected.

However, new claims and notifications of change submitted during the close will be assessed after the upgrade is complete.

While our customer service staff will still be

available to support residents, their access to information will be limited. Residents are encouraged to contact us only for urgent matters during this time.

We appreciate everyone's understanding and cooperation as we work towards improving our services for the benefit of the West Northamptonshire.

#### **RMTG Focuses on Young People**

Earlier this month, the Rural Market Towns Group (RMTG) held a sounding board session centred on the challenges and opportunities facing young people in rural communities. The session provided a platform for



representatives from various market town councils to share their insights, discuss pressing issues, and highlight initiatives that are making a difference. The discussion was framed around three main topics: the

biggest challenges facing young people, current initiatives and best practices, and desired policies for future support.

During the session, participants were asked to identify the three biggest issues facing young people in their communities. A common theme emerged around limited access to services and activities, leading to feelings of isolation and a lack of opportunities. The challenges have been exacerbated over the past three years by the impact of the COVID-19 pandemic, economic uncertainty, and changes in social behaviour.

The sounding board highlighted several successful initiatives aimed at supporting young people in rural communities. These examples of best practices demonstrate how councils can make a tangible difference in the lives of their younger residents.

#### **Soham Town Council Initiatives**

Soham Town Council has undertaken several initiatives to enhance the recreational spaces available to young people. The expansion of the local skatepark is a key project, providing a dedicated space for outdoor activities. Additionally, the council has installed picnic units in the recreation ground, although they have faced challenges with vandalism. Despite these setbacks, the council is committed to improving these spaces, demonstrating perseverance in the face of adversity. The council is also working to bring back the Youth Connection Bus, a mobile youth service that offers support and activities, which was delayed due to a lack of drivers.

#### **Cricklade Town Council, Wiltshire**

Cricklade Town Council has made significant strides in providing safe spaces for young people. Responding to issues of anti-social behaviour, the council established a weekly session for 13-18-year-olds at a local leisure centre. This initiative, initially supported by a grant from the Wiltshire Council area board, is now fully funded by Cricklade Town Council. The sessions are facilitated by The Rise Trust, which provides youth work support across North Wiltshire. The council also supports an annual skateboarding event and a youth festival, offering young people a chance to engage in new activities. These efforts have led to a reduction in anti-social behaviour and positive feedback from the community.

#### **Uppingham Youth Space**

Uppingham Youth Space offers a weekly drop-in session for 11-16-year-olds, run by a local charity at the Town Hall. This project aims to improve mental health and wellbeing by providing a space where young people can socialise, participate in activities, and receive support. Despite challenges in securing funding due to the town's image of affluence, the charity has successfully obtained a five-year grant from the National Lottery Community Fund and additional support from local organisations. The project has been a lifeline for many young people, particularly those who do not participate in sports, offering them a safe and supportive environment.

The RMTG sounding board provided valuable insights into the challenges facing young people in rural communities and highlighted innovative initiatives that are making a difference. The session highlighted the importance of continued support, both through local initiatives and government policy, to ensure that rural young people have the opportunities they need to thrive. The examples shared, from Soham to Uppingham, demonstrate the resilience and creativity of rural communities in addressing these challenges, offering a model for others to follow.

### **Consultation on Proposed Reforms to the National Planning Policy Framework NPPF**

On 30 July, MHCLG launched a consultation seeking views on proposed reforms to the National Planning Policy Framework and other changes to the system.

The consultation is open now and will close at 11.45pm on Tuesday 24 September 2024. A description of the key changes is provided below, but the full detail on the changes MHCLG propose to make are set out in the consultation document, with the draft track changed NPPF text found here.

The Government will respond to this consultation and publish NPPF revisions before the end of the year. Specifically, the changes proposed will:

- Make targets mandatory and reverse other changes made under the previous Government, which undermine housing supply.
- Implement a new standard method formula to ensure local plans are ambitious enough to support the Government's manifesto commitment of 1.5 million new homes in this Parliament.
- Identify grey belt land within the Green Belt, to be brought forward for homes and other important development through both plan and decisionmaking.



- Deliver affordable, well-designed homes, with new "golden rules" for land released in the Green Belt to ensure release delivers in the public interest.
- Make wider changes to ensure that local planning authorities can prioritise the types of affordable homes their communities need, and that the planning system supports a more diverse housebuilding sector.
- **Support economic growth** in key sectors, including laboratories, gigafactories, datacentres, digital economies and freight and logistics given their importance to our economic future.
- Deliver community needs to support society and the creation of healthy places; and
- **Support clean energy and the environment**, including through support for onshore wind and renewables.

Alongside these policy changes the Government are consulting on:

- whether to reform the way that the Nationally Significant Infrastructure Projects (NSIP) regime
  applies to renewable energy, commercial and water development, as the first step of the
  government's NSIP reform plans.
- whether the **local plan intervention policy** criteria should be updated or removed, so the Government can intervene where necessary to ensure housing delivery.
- proposals to increase some planning fees, including for householder applications, so that local
  planning authorities are properly resourced to support a sustained increase in development and
  improve performance.

Finally, it sets out how and when we expect **every local planning authority to rapidly create a clear, ambitious local plan** for high quality housebuilding and economic growth. For further information, please see the press release here:

### **Social and Affordable Housing**

The announcement on 30 July also set out how the Government is taking steps to provide more flexibility and certainty to councils and housing associations to deliver the biggest boost to social and affordable housing in a generation. This included increased flexibilities on how councils can use their Right to Buy Receipts and the launch of the third round of the Local Authority Housing Fund. The Government also pressed Homes England and the GLA to maximise the number of social rented homes in allocating the remaining funding in the 2021-2026 AHP. The announcement signalled the Government's intention to



review the Right to Buy scheme more widely, bring forward details of future Government investment in social and affordable housing at the spending review; set out plans at the next fiscal event to give councils and housing associations the rent stability; and introduce Awaab's Law into the social rented sector. More details will be shared in the Autumn.

#### **New Towns**

The Government have also set out how it intends to deliver on our commitment to build a new generation of new towns. This will include large-scale new communities built on greenfield land and separated from other nearby settlements, but also a larger number of urban extensions and urban regeneration schemes that will work will the grain of development in any given area. More details can be found here New Homes Accelerator Task Force the Chancellor announced the New Homes Accelerator Taskforce as part of her speech on 8 July, which included the first four schemes that the Taskforce and Homes England will support - Liverpool Central Docks, Worcester Parkway, Northstowe, and Langley Sutton Coldfield, together delivering more than 14,000 homes. Homes England is leading the effort to accelerate these schemes. MHCLG look forward to working with local planning departments to identify and unblock sites. More details on the Taskforce will follow in the next newsletter.

# HOUSING

### **Transforming Housing Through 5 Year Funding Regimes**

The Local Government Association (LGA) has published a comprehensive report, "Building a Better Future",

highlighting the critical economic and social advantages of implementing five-year housing funding regimes. This approach is positioned as a transformative solution to the enduring challenges of social housing



shortages, overcrowded living conditions, and homelessness across England.

#### **A Call for Consistent Funding**

For the past three decades, the growth in housing stock has lagged significantly behind demand. The current fragmented funding landscape, characterised by short-term, competitive funding pots, has led to inefficiencies and volatility in housing construction. The LGA report advocates for a shift to consistent, ringfenced funding allocated over five-year periods. Such a regime promises to stabilise housing construction efforts, streamline administrative processes, and ultimately deliver more social homes to those in need.

#### **Economic and Social Benefits**

The proposed five-year funding regime offers substantial economic and social benefits:

Increased Housing Supply: The certainty provided by secure, long-term funding is projected to lead to the construction of nearly 200,000 additional social homes over the next 30 years under current funding levels. With increased funding, this number could rise to almost 500,000 homes.

Financial Gains: The report estimates a net boost to public sector finances amounting to £3.3 billion over 30 years, potentially increasing to £5.6 billion with higher funding levels. These gains stem from reduced expenditures on temporary accommodation and homelessness services, as well as increased tax revenues from heightened construction activity.

Socioeconomic Impact: The construction of additional social homes is anticipated to generate socioeconomic benefits worth £31 billion, possibly reaching £56.1 billion with enhanced funding. These benefits include job creation, greater community stability, and improved living conditions for residents.

#### **Tailored Local Solutions**

One of the report's key recommendations is the devolution of housing funding and decision-making to local authorities. This would allow for more tailored and effective responses to the specific housing needs of different regions. By aligning housing strategies with local development plans and infrastructure projects, councils can ensure more cohesive and sustainable community growth.

In conclusion, LGA's "Building a Better Future" report makes a compelling case for the adoption of five-year housing funding regimes. By providing secure, long-term funding, local authorities can significantly enhance their housing delivery capabilities, resulting in substantial economic, social, and financial benefits. This strategic shift promises to alleviate the housing crisis, improve living conditions, and foster stronger, more resilient communities across England.

### **Challenges and Constraints in Housing Supply**

The Institute for Fiscal Studies (IFS) recently published a working paper on the determinants of local housing supply in England, shedding light on the underlying factors that contribute to regional disparities in housing availability.

The study estimates an average local housing supply elasticity of 0.14 over the period from 1996 to 2021,



indicating a limited responsiveness of housing supply to changes in demand. This is significantly lower compared to other countries like the US, France, and Germany. The low elasticity is attributed to several constraints including planning

policies, geographical factors, and land availability. In rural areas, these constraints are often more pronounced due to the preservation of agricultural land and protected natural areas.

The working paper identifies that areas with less land available for development, greater differences in elevation, higher historical population density, and stringent local planning authorities exhibit lower supply elasticities. Specifically, the share of land available for development and pre-existing urban density are highlighted as major determinants, accounting for 80% of the variation in local housing supply responses. In rural areas, the availability of developable land is often further constrained by agricultural use and protected land designations, such as Green Belts and national parks.

Rural areas face unique challenges in housing supply. The constraints of land use, combined with stringent planning policies, often limit the ability to develop new housing. This leads to increased housing prices and reduced availability, which can hinder economic growth and demographic diversity in rural communities. The working paper suggests that if rural areas had housing supply elasticities comparable to more flexible regions, they could better accommodate population growth and housing demand.

The analysis reveals stark regional differences in housing supply responses. London and other urban areas, despite significant demand, have a poor record of building homes where they are needed the most. Conversely, areas like the East of England, with fewer geographical constraints, show higher elasticity and better responsiveness to demand changes. Rural areas, particularly those with stringent land use policies and significant geographical constraints, exhibit some of the lowest supply elasticities.

The findings highlight the need for policy interventions tailored to the unique challenges of rural areas. Simplifying planning processes, increasing the availability of developable land, and re-evaluating land-use restrictions, particularly in rural regions, could enhance housing supply elasticity. Additionally, targeted policies to incentivize development in rural high-demand areas could help mitigate the housing shortage and promote sustainable rural communities.

The IFS working paper provides crucial insights into the factors limiting housing supply in England. Addressing these constraints is imperative for improving housing affordability and ensuring that homes are built where they are most needed. Policymakers must consider these findings to formulate effective housing strategies that align with regional demands and geographical realities, especially in rural settings. WNC has approved a capital budget of £12.372 million to provide relocatable temporary accommodation

as part of our ongoing efforts to address the rising need for temporary housing in the area. The plan includes the delivery of around 100 units of relocatable temporary accommodation across two sites in Northampton, reducing the reliance on expensive and less stable options like nightly lets and bed and breakfast accommodation. The units - known as relocatable temporary accommodation (or reTA) - are designed to be genuinely relocatable, ensuring minimal regret costs and maximum flexibility. They will support



residents in securing stable addresses, which is essential for accessing employment and other opportunities and helping them transition back to conventional housing.

The project is estimated to save the Council approximately £667,000 annually by providing a more cost-effective alternative to current temporary housing solutions.

By providing stable and cost-effective housing solutions, we are not only addressing immediate needs but also laying the groundwork for long-term benefits for our community. This initiative underscores our dedication to improving the quality of life for our residents and ensuring that everyone has access to safe and appropriate housing.

The Council has explored various strategies to tackle the housing crisis, including acquiring properties on the open market and increasing affordable housing delivery. However, the introduction of reTA is seen as a necessary and innovative step to complement these efforts and ensure adequate housing provision for those with an immediate housing need until a permanent accommodation solution is found.

The project will also involve the development of housing management and support services to help residents prepare for a successful transition to permanent housing. Detailed planning and procurement processes will follow to ensure the efficient and effective implementation of the reTA units.

# **ENVIRONMENT**

### Bird Keepers Urged to Register their Flock.

West Northamptonshire Trading Standards Team are urging everyone who keeps poultry or captive birds to



register with the Animal and Plant Health Agency (APHA). Currently, anyone who keeps 50 or more birds it is compulsory to register their flock, however, those with fewer birds can voluntarily register. From 1 October, new requirements for all bird keepers who keep their poultry outdoors - regardless of the size of their flock – will come in which will require any who owns captive birds or poultry must officially register their birds. The new rules cover owners of backyard flocks, birds of prey and pigeon fanciers, but do not affect caged pet birds (excluding any poultry species) kept entirely inside a domestic dwelling,

such as a parrot, canary or budgie, which never leaves the property other than to visit a vet or another short-term period.

By registering their birds, keepers will ensure they receive important updates relevant to them, such as on any local avian disease outbreaks and information on biosecurity rules to help protect their flocks. This will help to manage potential disease outbreaks, such as avian influenza and Newcastle disease, and limit any spread. It also enables them to keep up to date with the latest national and regional guidance.

#### **Five Year Strategy for Unpaid Carers**

West Northamptonshire Council (WNC) has adopted a five-year strategy which sets out the vision to support unpaid carers across the area, helping them to find a balance between their caring responsibilities and maintaining their own health and lifestyle.

A carer is someone who selflessly offers unpaid assistance to their partner, family member, friend or



neighbour who may be unwell, have a disability or struggle without this essential help.

The carers strategy (2024-29) is for all unpaid carers that live in, or care for someone that lives in West Northants, and has been developed together with local carers, ensuring their voices drive forward progress over the next few years to provide the right support and information for them.

Chosen by our local carers, 17 priorities have been identified to focus on improving over the next five years as well as specific

measurements to track progress. Each one has a set of actions that will support with achieving the priority over the five-year period.

Work is now underway to roll-out the priorities set out in year one which include:

- A One-Stop Shop delivered in all our Local Area Partnerships (LAPs) for carers to meet other carers, find support and be given information.
- Develop and provide a carer guide in both written format and available on an app.
- Find hidden carers who are people that do not yet recognise themselves as a carer and offer them support.

Over the next five-years WNC will work with North Northamptonshire Council and health colleagues to deliver the ambitions set out in the strategy and ensure that carers receive the support they need.

### **Drug Warning and Alcohol Guidance Issued**

Northamptonshire's Combatting Drugs and Alcohol Partnership is issuing a warning about the latest dangerous drugs in circulation in the county and across the UK.

The Partnership, which is made up of police, health organisations, local drug and alcohol services, and West and North Northamptonshire Councils, has been alerted to an increasing number of incidents in recent months where drug users have experienced very poor health from taking street drugs, including heroin and cocaine, requiring emergency medical treatment.

The new group of drugs called synthetic opioids, sometimes known as Nitazenes, pose a substantial risk of overdose, drug-related hospitalisation, and drug-related death. The synthetic opioids are combined with



street drugs, including heroin, which users may not be aware contains Nitazene. Anyone taking drugs is urged to take extra care and to alert the family and friends of those using street drugs to the danger of synthetic opioids.

Colleagues across the Northamptonshire Combatting Drugs and Alcohol Partnership want to ensure we protect people from harm by raising awareness of the dangerous drugs circulating in Northamptonshire and across the UK because of the devastating impact they can have.

There are services across Northamptonshire which provide treatment for drug users and those recovering from addiction, and this includes adults and young people. Anyone with any information or concerns about drugs in their community is urged to call the police on 101 or Crimestoppers anonymously on 0800 555 111. #### **September Focus towards Improving Send Assessments**

Priority work on improving services for children with special needs and disabilities (SEND) in West Northamptonshire continues to progress, with extra staff starting next month to focus on tackling the increased demand for education health and care plans (EHCPs).

Seven dedicated EHC caseworkers will be joining West Northamptonshire Council (WNC) at the start of the new school year in September to improve the timeliness and quality of these pivotal assessments for families requesting SEND support.



The work is a key area for improvement identified in the recent Ofsted inspection of West Northamptonshire's SEND Partnership, which highlighted significant concerns about the services currently provided to children and their families in the area.

The Council is working with partners to progress a broad range of actions to address the report's findings, and recently committed to increasing capacity of its SEND team to help meet the unprecedented demand

for the services – having experienced in its first few years as a council a 40 per cent increase in EHCP requests (an increase of over 1,000).


Work is already under way to address the issues, with WNC also recently commissioning a team of Educational Psychologists to support with overdue EHC assessments, setting a positive trajectory for improvement. Although there is still much work to do, the additional resource is starting to make an impact, with 42% of EHCPs issued within the 20-week statutory timescale in June 2024 – a significant increase from the 2023 average of 6%. 139 plans have been issued since the start of the priority action plan, with 20.1% of these issued within 20 weeks.

The Partnership is now focusing on several priority actions that require urgent attention to address the findings of the report which can be found on our SEND pages.

# **ECONOMIC DEVELOPMENT & GRANT FUNDING**

### WNC Awarded £1.4m for Skills and to Grow Economy

West Northamptonshire Council (WNC) has awarded £1.4 million in grant funding to a wide range of projects, including 24 community organisations to support initiatives focused on enhancing local skills, addressing critical needs, and fostering positive change within the community. Funded by the UK Shared Prosperity Fund (UKSPF), the People and Skills Grant funding is designed to empower individuals and grassroots organisations by providing the resources needed to cultivate essential skills and foster a resilient workforce equipped to meet evolving needs and drive economic growth. The largest part of the skills programme is an initiative called "Skills for Communities", providing community organisations with funding to deliver innovative skills projects. The successful grant recipients were selected through a competitive process based on their innovative approaches and potential for significant community impact. The funded projects cover a wide range of areas, including Not in Education; Employment or Training (NEET); Digital Literacy, Science Technology Engineering Maths (STEM), English Speakers of Other Languages (ESOL) Literacy at Work; and inclusive recruitment.



Support on offer will include one to one personalised coaching to help people get back into work, help for families in crisis, increased volunteering opportunities, therapeutic sessions to support adults' mental health and emotional wellbeing, and a programme to tackle social exclusion in young people. The primary objectives of the People and Skills Grant Funding program include:

- Enhancing Workforce Skills and providing targeted training programs to help individuals acquire
  new competencies and advance their career and employment prospects, such as Digital and
  Literacy Skills in the Workplace.
- Promoting Inclusivity by ensuring equitable access to skill development opportunities for underrepresented and disadvantaged groups, such as those for whom English is a second language (ESOL) or those looking to improve their levels of Literacy at Work.
- Supporting Innovation and encouraging the development of innovative solutions to address current and future skill needs, such as STEM Skills.
- Strengthening Community Resilience and building a robust and adaptable workforce that can thrive
  in a rapidly changing economic landscape, focusing on supporting individuals recovering from longterm health challenges or those leaving care to engage with employment opportunities and
  training.

### **Construction Works Underway for New Shopping District**

The works on Fish Street, as part of a wider regeneration project to Northampton town centre, are well underway with new lettering cementing the rejuvenation of this part of the town. West Northamptonshire

Council is working with Kier Transportation to carry out vital works to enhance the appearance of Abington Street and Fish Street. Since March, nearly 900m2 of paving has been installed on Fish Street, along with an improved drainage system and fish themed paving designs. This project will lift the quality of the public spaces through high quality materials, increasing seating and planting, introducing new art and play opportunities along the street, as well as space for outdoor dining and community activity.



Businesses in the area have been kept up to date with the project's phases, and the project's dedicated single point of contact has been working closely to ensure they have been able to operate with minimal disruption. The redevelopment will complement the wider Market Square transformation and provide enhanced connectivity with the rest of the town. Work continues with the completion of Abington Street repaving, the upgrade and installation of street lighting, installation of street furniture, planting of new trees, and minor finishing touches. The project is set to be complete in Winter 2024/2025 and will be thoroughly cleaned once all construction works are completed. 

### Warning over Fake Car Park QR Codes

WNC has told drivers to be vigilant after fake QR codes were placed on some of its parking machines. (A





West Northamptonshire Council said the code would take users to a fake site which asked for payment information and other personal details. Following payment, the parking would then not be valid.

In a tweet, the council said it "offers no services via QR codes and these should not be used at any Northampton car parks or

country parks. WNC said its team would be checking all car parks to "prevent further scams."

### WNC awarded £1.9 million in grant funding across West Northants

West Northamptonshire Council (WNC) has awarded over £1.9 million in grant funding to local Voluntary and Community Sector organisations to enable them to deliver a range of projects and initiatives across

West Northants. The funding has been awarded, over two years, as part of three Community Funding Grant Schemes using £655k from Central Government via the UK Shared Prosperity Fund (UKSPF) and Rural England Prosperity Fund (REPF). Initiatives that will be delivered using the funding include improved community transport services; debt and money, and immigration advice services; and additional support for local infrastructure organisations to help them grow and meet the needs of the local



voluntary, community and social enterprise sector. Seven community transport operators have been awarded funding totalling £951k to provide safe and cost-efficient community transport options across West Northants which aim to increase accessibility and inclusion and reduce social isolation. The successful organisations are:

Voluntary Impact Northamptonshire, in partnership with Daventry Volunteer Centre and South Northants Volunteer Bureau, were also successful in winning £260k of funding which will be used to bring together

and strengthen diverse groups and marginalised communities and support the local voluntary and community sector.

Citizens Advice West Northamptonshire and Cherwell (CAWNAC) have teamed up with Community Law Service (CLS) following £620k of funding which will be used to provide debt and money advice services and provide early intervention and support to help prevent people from experiencing financial crisis and issues such as bankruptcy and eviction.

CLS alongside Northamptonshire Rights and Equality Council have also been allocated £116,164 to provide immigration support, including providing individuals with legal guidance to understand their rights, options, and obligations under immigration law and protecting the Human Rights of individuals fleeing persecution, violence, or other forms of harm.

# **POLICE FIRE & CRIME COMMISSIONER**

### Police officers to pilot use of potentially life-saving nasal spray for drug overdose.

Several Northamptonshire Police officers are being trained in the use of Naloxone – a medical nasal spray designed to save lives of people who have suffered a drug overdose. Neighbourhood officers working on



the Operation Revive programme in Northampton, Wellingborough and Kettering, will now be carrying the spray, having been trained and certified in its use. More frontline officers will soon also be able to choose to carry Naloxone when the specialised training is rolled out further. The nasal spray is an emergency antidote for overdoses caused by heroin and other opiates or opioids. The medication works by temporarily reversing the effects of the overdose by reversing the depression of the central nervous and respiratory systems.

In 2005, Naloxone was added to a list of medicines that anyone can legally administer in an emergency to save a life. Since February 2019, Naloxone has been available in a pre-packaged nasal spray. The spray delivers Naloxone up the nose where it is quickly absorbed and blocks the drug from affecting the body. The reaction is usually very quick and prevents the opioid from blocking the breathing centres of the brain which would cause suffocation - the main cause of death in opioid overdose — and in turn buying valuable time to keep the subject alive pending arrival of paramedics. The carrying of Naloxone by officers is voluntary and full training will be provided to all officers who sign up to the scheme. The Force is working with partners including with Public Heath England, CGL and S2S as part of the pilot.

### **Chimney Fire Safety Week is Next Week**

The annual campaign will run from Monday 2nd September - Sunday 8th September 2024. This campaign strives to raise awareness of chimney fires and encourages consumers to take appropriate action. As the national fire and rescue statistics show, chimney fires have been steadily decreasing in most regions over the years, despite recent wood burner popularity. In England across 2023-24, chimney fire incidents reduced by



16.29% in comparison to 2022-23, representing approximately 1.5% of the total fires for 2023-24.

The total number of chimney fires which occurred in England during 2023-24 is 2126, with incidents peaking January – March. Statistics show that 40% of chimney fires in England take place over these three months, coinciding with the period where people will be using their stoves the most. https://www.hetas.co.uk/chimney-fire-safety-week-2024/

Franklin's Gardens stadium has been announced as a venue for one of England's matches during the pool phase of the Women's Rugby World Cup 2025 tournament. The 15,000-capacity stadium - home of course

to the Premiership champions Northampton Saints - will host a Red Roses match during the 10th edition of the pinnacle women's rugby event taking place across six weekends from 22 August to 27 September next year. The full match schedule and kick-off times will be announced in October, when fans will be able to buy tickets for what promises to be the biggest-ever global celebration of women's rugby.



It will be a chance to watch the world's 16 best teams

and the biggest stars of the game compete at eight locations across the length and breadth of the country, culminating in a grand finale at Twickenham Stadium. Ticket prices will range from £5 to £95 across the tournament, with over 60 per cent of tickets under £25 and children's prices available at every match. Accessible tickets will also be available for all matches.

### **West Northants Stage Route for Men's Cycle Race**

For the first time, Northamptonshire will host part of the 2024 Lloyds Bank Tour of Britain Men's cycling competition. Stage five will take place on 7 September 2024 starting from the University of Northampton



and finishing with a sprint into the town centre by the Guildhall. The rest of the 91-mile route will see riders cycle through Daventry and nearly 30 villages. While it is the first time the men's tour has come to Northampton, the town hosted the first-ever stage finish of the women's tour in May 2014, and Daventry has twice hosted the women's race, in 2017 and 2018. During this year's race, the men's route will go through Daventry, followed by a loop south of the town through villages including Abthorpe, Wappenham, and Helmdon. Cyclists will

then go through Culworth, Byfield and Hellidon, before looping around Northampton via Watford, West Haddon, Naseby, Kelmarsh and Brixworth for the approach to the finish via Sywell and Ecton.

The race begins in the Scottish Borders on 3 September 2024 followed by stages in the Tees Valley, South Yorkshire and East Midlands. Following the West Northamptonshire stage, the race concludes in Suffolk on 8 September 2024.

During the stage riders will tackle a pair of categorised King of the Mountains climbs at Newnham Hill and Bulls Hill, just south of Daventry, and an intermediate sprint at Holcot, at the eastern end of the Pitsford Water causeway.

Team GB Olympic gold medallist Tom Pidcock is set to be among the riders when the Lloyds Bank Tour of Britain cycling race visits West Northamptonshire on Saturday 7 September.

Pidcock, who won the thrilling cross-country mountain bike race in Paris, will compete in the Tour for INEOS Grenadiers. https://www.bbc.co.uk/sport/olympics/articles/c29dkdrxnnro

The 25-year-old joins the likes of double Olympic champion Remco Evenepoel, and former race winner Julian Alaphilippe (both racing for Soudal Quick-Step) on the provisional start list for the 20th edition of Britain's biggest professional cycle race.

The West Northants stage <a href="https://www.westnorthants.gov.uk/tour-britain-men">https://www.westnorthants.gov.uk/tour-britain-men</a> will start from the University of Northampton at 11am and weave its way around West Northants before finishing at the Guildhall in Northampton from around 2.20pm.

The route will visit Daventry and around 30 villages across West Northants, and communities are encouraged to come out and cheer on the cyclists as they race towards the finish line.

The stage will feature two 'King of the Mountain' climbs - at Newnham Hill and Bulls Hill, just south of Daventry. There will also be an intermediate sprint on Pitsford Causeway - offering plenty of opportunities for spectators to find the perfect spot from which to witness the race.

Events and activities will be taking place at the

University of Northampton's Waterside Campus throughout the day.
