NEWS REPORT OCTOBER 2024

Monthly Highlights

WNC is proposing to implement a 50-mph speed limit to replace the derestricted signs on the entrance to and exit from Little Houghton. WNC will proceed to final design, pricing and scheduling. Once I have further news, I will be in touch.

Highways have advised me that temporary traffic works are in place on the A428 to reduce stress on a failing structure, which is described as 'parapet repairs'. They are working at planning repairs, but they are complex. The two- way traffic signals will remain in place as a 24-hour safety measure until the works are completed.

Kier Transportation, working together with West Northamptonshire Council, will be undertaking repair works to a damaged surface water drain on Nene Rise, Cogenhoe, from 14 October-22 October 2024

Highways response teams for Kier and West Northamptonshire Council have been out and about supporting emergency services, having attended 200 incidents during the recent flooding, three quarters of which were flooding related with the remainder a mix of emergencies, such as fallen trees and dislodged/broken manhole covers.

Please visit the 'Give us your views on Pharmaceutical Needs' Consultation, which closes midnight Sunday 6 October 2024.

Residents and stakeholders are invited to provide their input to an HMO Licencing Strategy by taking part in the survey via West Northamptonshire Council's consultation hub before midnight on Monday 7 October 2024.

Residents, businesses, and community groups are invited to take part in an online pre-planning consultation for the proposed Wantage Park crematorium and celebration facility. The online engagement will run until Wednesday 16 October 2024.

We are in the process of finalising our Tree and Woods Strategy, setting out how we will manage, protect and expand tree and woodland cover across West Northants to 2045, as well as how we intend to collaborate with partners and the wider community. The deadline for comments is Sunday 13 October 2024.

If you think that there is not enough in the Local Transport Plan for you or your community then please respond to the consultation, which runs until 17 October 2024.

We have launched a survey for anyone in West Northants who has experienced domestic abuse. See my Monthly Report.

We are looking for feedback on Heritage Open Days. This survey closes at midnight on 31 October 2024

Adult Social Care will be at Welcoming Spaces, Towcester Library on 8 October 2024 from 10am – 12pm, no appointment is needed.

The council's annual canvass is now well underway. If we do not receive a response to our form, we will make every attempt to get a response from you. This may include sending reminder forms, text / email, telephone calls, or visiting your property between September and November 2024.

Trading Standards team is encouraging livestock owners in the county to familiarise themselves with the signs to look out for in relation to bluetongue virus. See Monthly Report.

At the WNC Planning Policy Meeting on 18 September 2024, we considered the Council's response to the current Government consultation on Reforms to the National Planning Policy Framework (NPPF). For West Northamptonshire, this would see the annual requirement increase from 2,124 to 2,584 per annum, a total additional requirement of 13,000 dwellings by 2041. See my quote, which was picked up by 'Cambridgeshire Live' in their article of 23 September 2024 in my Monthly Report. For WNC to comply with the new changes to the NPPF then there would need to be a thorough analysis of the shortfall of infrastructure to include roads, rural transport, schools, electricity, water, heating supply, hospitals and other medical facilities together with a report on green space with a view to creating buffer areas to prevent our village boundaries coalescing and avoiding ribbon development. We need to acquire this infrastructure ahead of any development as we cannot continue to ignore the existing deficit in essential infrastructure in our rural areas.

WNC has approved a capital budget of £12.372 million to provide relocatable temporary accommodation as part of our ongoing efforts to address the rising need for temporary housing in the area. See my Monthly Report.

West Northamptonshire is gearing up for an unforgettable weekend as the newly revitalised and reimagined Northampton Market Square prepares to reopen with a spectacular celebration on Saturday 19 and Sunday 20 October 2024.

WNC has supported a campaign calling for the 'Women Against State Pension Inequality' (Waspi) women adversely impacted by changes to the state pension age to be compensated. See My Monthly Report.

Ability, a community transport service is expanding its fleet thanks to a grant of £477,181 from West Northamptonshire Council (WNC). Ability has used the money to buy four new minibuses increasing the size of its fleet to 14 vehicles. Ability is one of seven community transport operators to receive money from a £951,000 pot set up by West Northamptonshire Council thanks to the Government's Rural England Prosperity Fund (REPF) and UK Shared Prosperity Fund (UKSPF). In Ability's case, the majority came from REPF. Brackley Volunteer Car Scheme, Cogenhoe & Whiston Parish Council's Village Hopper service, the Comm Minibus, Daventry Area Community Transport, Northampton Door to Door and Towcester Area Door to Door all also benefited from a share of the funds.

More than 100 people have been referred to the 'Immediate Justice Scheme' helping to repair the damage they have caused to local communities by anti-social behaviour. See My Monthly Report.



Great Houghton Coffee Morning 13 September 2024

On 13 September 2024, I attended the Community Coffee Morning run by the WI at the Great Houghton Village Hall. It is held on 2nd Friday of each month and a cup of tea or coffee with cake will cost you just £2.50.

It was great to meet with Mike Billingham, Clerk Great Houghton Parish Council and we briefly discussed recent events. Before leaving, I was able to speak to Revd Irene Cobley and others. Very soon, the hour and a half flew by and then, I helped pack up tables and chairs. The next meeting of this friendly and welcoming group will be 11 October 2024, when I look forward to catching up with everyone again.



Ride & Stride 14 September 2024

Saturday 14 September 2024 was the day that all of Northamptonshire's Historic Churches (NHC) were open for the annual sponsored Ride and Stride. It is a sponsored event for cyclists, joggers, walkers and horse riders. Indeed, any mode of transport can be used if your sponsors are happy. I did a combination of car and walking. Half the money you raise comes directly to your chosen church and the other half to the NHC Trust to give grants towards the restoration of churches in the County. The event ran from 10am to 6pm.

This year is the fourth year that I have taken part. However, I couldn't start until after a meeting of WNC Councillors, which took place in Northampton that morning. My first stop was the Church of St Mary

Blessed Virgin at Great Houghton. Little is known of the medieval church, which was dedicated to the Assumption and described by Bridges in his history of Northamptonshire as having had a chancel and aisled nave.



Northamptonshire Historic Churches Trust y No 1021632 For more details see our website: <u>www.nhct.org.uk</u> My second stop was at the Church of St Mary the Virgin, Bedford Road, Little Houghton. I am very familiar with this church as we attend lots of community events here. The Church is thought to be C13-C15, but altered late C18/early C19. The body of the church was rebuilt in 1873 and otherwise restored by Charles Buckeridge.

I had missed their monthly coffee morning earlier when the church would have been quite full. Now there was just one person signing forms as we arrived following the same cyclists we had seen at Great Houghton.

Our third stop was the Church of St Laurence, Brafield on the Green. The oldest part of the church is some seven hundred and fifty years old, however much of the church was changed and rebuilt in the Victorian times. This time, I did see the small statue of St. Laurence which is over the porch on the South side when you approach by the main path through the Churchyard.

Afterwards, we continued to our fourth stop which was St Margaret's Church Denton. We are frequently at the Church of St Margaret of Antioch, for their village coffee morning on a Friday so we were on very

familiar territory. The Church is C13 , rebuilt in C17 and again in 1827-8 by Charles Squarhill. The small 3-stage tower has a lancet window to the bottom and there is a large 12-sided cast iron clock dial above. The mural scheme of 1976, devised by Reverend Eltoft, by William Bird with scenes from the Bible, the lives of saints and village history with foliage backgrounds evoking the months of the year. Bird was a well-respected theatrical scene painter and anybody attending the Theatre Royal in Northampton will be familiar with his safety curtain. Denton was his largest project and his masterpiece. The Church was originally a chapel-of-ease of Yardley Hastings.



After a most delightful cup of tea and much chat with our friends

who also attend the Friday Coffee Morning we carried on to our next stop in Castle Ashby. Our fifth stop on the NHCT Ride & Stride was at the Church of St Mary Magdalene, Castle Ashby. The church is thought to be C14 and C15 with older origins. It was restored in 1869 by G.E. Street. There is a complete set of tiled floors by Minton to designs by Lord Alwyne Compton. Once inside, you can't fail to notice the large monument at the west end of the church made by Pietro Tenerani (1789-1870), who was the principle Italian sculptor following the death of Canova. It was sculpted in Rome and shipped to England in 1856. The over life size Angel of the Resurrection, carrying his trump (for the last) and his book of the saved, dominates the inscribed plinth. It's such a fine church and we have been there several times for different organ recitals. But today the church was very silent.

Our sixth Ride and Stride visit was to the Church of St Andrew, Church Lane, Yardley Hastings. The Church is C13-C14 and restored during the period 1883-1889. The architect for the restoration of the church, George Sutherland, was clerk of the works to the Castle Ashby estate. The work was carried out by the estate at the expense of 4th Marquis of Northampton. Yardley Hastings. It is a fine example of a great South Northamptonshire village, and the church is hidden away.

Our seventh stop on the NHCT Ride & Stride was at the Church of St Peter, Cogenhoe. We were able to get some refreshments and the opportunity to get our sponsor forms signed. The Church is thought to be C13 with older origins, C14 and C15. It was restored in 1868 by C. Buckeridge.

In previous years we had visited more churches as we started our journey at 9.30am. Despite setting off at 1.45pm we still managed to support seven churches. We were pleased with our efforts, as those churches will benefit from our sponsorship. All money raised during 'Ride and Stride' helps Northamptonshire Historic Churches Trust (NHCT) to continue supporting our marvellous churches across the county with essential repairs and improvements.

Castle Ashby House Organ Concert 21 September 2024

On Saturday 21 September 2024, I attended an Organ Concert with Daniel Moult at the Great Hall, Castle

Ashby House. I would like to thank the Castle Ashby Trustees for their kind permission to host this event in Castle Ashby House to sustain the work of St Mary Magdalene, Castle Ashby. Whilst Castle Ashby House is not open to the public, in recognition of the 150th anniversary of the church organ, another Nicholson (1872), the Castle Ashby Trustees had generously agreed that the organ of the Great Hall could be heard in a special concert on 3 September 2022. So here we were two years later enjoying another very special evening. Daniel Mould is an outstanding international organist and is one of the finest organists of our time. He gave an excellent performance as he took us through a varied and exhilarating



programme. I particularly enjoyed his Handel-La Rejouissance and Largo together with his Bach-Trio in G. I was fortunate to be able to talk to Daniel during the interval again. He was very engaging, and I was able talk to him about the Phelps organ which I heard being played whilst visiting Hexham Abbey last month. Daniel is the Head of Organ Studies at the Royal Birmingham Conservatoire, where he directs the highly acclaimed organ department. He has spearheaded the commissioning of and is the main consultant for the five new organs at the Conservatoire. The first of these is the recently installed Wolfson Flentrop organ in the style of Arp Schnitger, which was joined by a new Drake organ in Summer 2024.

Northants & Rutland Open Studios 22 September 2024

On 22 September 2024, I joined many others at St John the Baptist Church in Blisworth to meet and chat with local artists. It was the last day and there was a range of techniques on display including glass, ceramics, watercolours, oils, acrylics, stone, carving and photography. It was great to catch up with June, Anne Marie and others again.

The Northants and Rutland Open Studios Visual Arts Festival is an annual event, which turns the spotlight on artists and their creative process, showcasing the talent of over 220 artists across 116 venues throughout Northamptonshire.

Thank you to everyone who is involved in making this event such a success.

Yardley Hastings MacMillan Coffee Morning 27 September 2024

On 27 September 2024, I joined lots of residents at the Yardley Hastings MacMillan Coffee Morning at the Memorial Hall, 7 Northampton Road,



Yardley Hastings, Northamptonshire, NN7 1EX. Everyone had decided to venture out after having stayed at home during the recent heavy rain and flooding.

MacMillan Coffee Mornings are usually on the last Friday of September each year and this year's Coffee Morning Day is Friday 27 September 2024. However, you can host any time of the year, whenever it suits you best. It is the biggest fundraising event to support people living with cancer and since 1990, the annual coffee morning has brought together millions of people from across the UK to have fun and raise money for a good cause. Temporary Traffic Lights on A428

On 12 August 2024, I promised to give you a further update on the temporary traffic lights on the A428.

On 2 September 2024, I received the following explanation from Highways:

"As soon as Kier was made aware of the vehicle accident which destroyed all of the parapet at the end of June, WNC took immediate action to arrange the

temporary exposed



protection of the edge of the bridge.

WNC then contacted its parapet sub-contractor to supply a new parapet. However, due to the age of the bridge, the parapet systems available now don't match the fixings of the old parapet. There is a lead-in time for the parapet manufacturer to both design and fabricate the replacement parapet. After this has been completed, WNC will then programme the works. The accident also damaged part of the

concrete support to the parapet, and

this will be repaired when the new parapet is installed.

am asking that this item be resolved







for any subsequent planning application. Section 25 of the Localism Act 2011 provides that a decision maker is not to be taken to have had, or appeared to have had, a closed mind when making the decision just because:

- (a) the decision maker had previously done anything that directly or indirectly indicated what view the decision maker took, or would or might take, in relation to a matter; and
- (b) the matter was relevant to the decision.

This provision does not change the law on bias and pre-determination which means that Committee Members must still take planning decisions with an open mind and having considered all relevant material planning considerations. The safest course is for Committee Members to avoid making public statements (including expressing views in emails) as to their support for or opposition to any application which would indicate they had made up their minds before the formal consideration of the application at the meeting. If a Committee Member has made such a statement, they must be satisfied that they can still consider the

application with an open mind and are prepared to consider any new matters or any new arguments in favour of or against the proposed development until the decision is made otherwise, they should not take part in any decision on the application in question.

On the grounds of the above, it would not be appropriate for me to attend Parish Council or Community events which seek to take a decision regarding the outcome of a planning application as I must keep an open mind on this matter so as not to preclude me from participating in any future planning decisions.

HMO Licensing Consultation

West Northamptonshire Council (WNC) is seeking residents' views on a new proposed licensing scheme which includes additional licensing areas for homes in multiple occupation (HMOs).

An HMO is a property where more than 3 people that form more than one household, rent a home, and

share some facilities such as the kitchen or a bathroom in the home with the other tenants.

HMOs can include:

- a house let as individual bed-sitting rooms.
- a group of rooms on each floor let to single occupants.
- hostels, some hotels and guesthouses.
- lodgings and shared houses
- houses converted into self-contained flats.

The new scheme will be a continuation of the existing scheme introduced in 2020, but extended to



include areas of new development, areas where the level of anti-social behaviour or property conditions indicate that further intervention is necessary, and to bring a closer alignment of the Additional Licensing designation to the Council's Article 4 restrictions under the Town and Country Planning Act.

A street list and map of the existing areas and proposed additional licensing areas can be viewed in the consultation documents.

Landlords in the enhanced designated area will need to apply for a HMO licence, failure to do so could result in conviction and an unlimited fine through the courts or a civil penalty of up to £30,000 through the Council's powers under the Housing and Planning Act 2016.

They might also have to pay back up to a year's rent to either the tenant, or the Council in the case of Housing Benefit, if a rent repayment order is applied for.

The current Additional HMO Licensing scheme ends on 31 January 2025 and, if approved, the new additional five-year scheme will come into effect as soon as possible after 1 February 2025.

The 10-week consultation aims to gather residents' thoughts on these proposals as well as input on how to improve housing standards and ensure safe, well-maintained accommodation for everyone.

WNC's Cabinet will consider a report on the proposed scheme, including results from the consultation, at its meeting in November 2024. Wantage Park will offer a range of features designed to meet the diverse needs of our community, including level access across the site, accessible parking, adaptable lighting for neuro diverse individuals, and multi-functional spaces for community use. The proposed design will be inclusive, accommodating various faiths and providing spaces that respect the privacy and dignity of all users.

REGULATORY SERVICES

Complete Annual Canvass Paperwork Promptly

West Northamptonshire Council is reminding residents to complete their annual canvass paperwork as soon as possible. The council's annual canvass is now well underway, with every property in the area having received a canvass communication either through email or letter. The canvass is a legal requirement, enabling the council to maintain a current and precise electoral register. Being on the register



is essential for adults to be able to exercise their right to vote in elections and referendums. Additionally, it plays a crucial role in jury service selection and is often used in credit checks for mortgages and other financial purposes.

Residents who have provided their email addresses to the council should have already received a branded email from West Northamptonshire Council. The email, sent from mailto:electoralservices@westnorthants.gov.uk,

contains step-by-step instructions on how to check, confirm, and/or change your details online. Those who did not respond by Monday, 9 September, will receive a reminder letter at their property. Some households will also receive a form to complete. We urge you to respond promptly to the email or form to save the cost of sending reminders. This year, the council is also required to review all European citizens registered to vote. If we cannot confirm that an EU voter has resided in the UK before 31 December 2020 by checking historical electoral records, a letter or email will be sent to the voter to confirm their eligibility under the new criteria.

EU citizens who receive a letter confirming their eligibility to vote do not need to take further action. They remain eligible and can vote in upcoming elections, excluding UK Parliamentary elections.


If you're not currently registered to vote, you can easily register online or call 0300 126 7000. People are also reminded to be cautious of phishing, scams, or spam emails during this time. West Northamptonshire Council will never ask for personal or banking details via email. If you have any concerns or doubts, please contact us on 0300 126 7000.

If we do not receive a response to our form, we will make every attempt to get a response from you. This may include sending reminder forms, text / email, telephone calls, or visiting your property between September and November 2024. Please watch out for Signs of Bluetongue Virus

Our Trading Standards teams are encouraging people to be aware of the signs of the bluetongue virus, following the recent discovery of cases in some parts of the UK. Bluetongue is transmitted by biting midges and affects cattle, sheep, goats and deer as well as camelids such as llama and alpacas. The impacts on these animals can vary greatly but, in the most severe cases, can be fatal. It does



not affect human health or food safety. No confirmed cases have been found in Northamptonshire, however restricted zones have been set up in the East Riding of Yorkshire and Lincolnshire, as well as in Norfolk, Suffolk, Essex, Kent, East Sussex and part of Greater London following the identification of cases in those areas.

Rural Economy & Regeneration-16 September

On 16 September 2024, I attended the Rural Services Network (RSN) Rural Economy & Regeneration Session on-line and I heard Till Specht, Head of Funding Design & Strategy MHCLG tell us 'What's next for Local Growth'.

On 29th July the Chancellor made a statement to the House of Commons setting out the current fiscal position whilst launching a Spending Review. This means that MHCLG alongside other departments, is:

- Looking to deliver more efficiently.
- Preparing a budget pitch for 30th October
- Developing proposals for the multi-year Spending Review in April.



mater year specialing neview in April.

Over the last Parliament, MHCLG launched and delivered a large variety of local growth funds:

- Future High Streets Fund
- Town Deals
- Community Renewal Fund
- Levelling Up Fund
- UK Shared Prosperity Fund
- Long Term Plan for Towns

Alongside many other funds launched by other departments, which has made the funding landscape complex and hard to navigate.

As a result, Government is now seeking continuous improvement of delivery models, whilst they continue to pursue devolution deals and to deepen existing ones. MHCLG and HMT introduced the Funding Simplification Doctrine at the beginning of the year, which requires government departments to consider the impact of their fund design on Local Authorities. Government's ambition is to design a simplified funding landscape, delivering better returns than our current set of funds while providing an incentive for further devolution.

This means that they are looking at:

- Reducing the monitoring burden on places
- Integrating capital and revenue funding
- Reducing the number of funding pots with individual rules
- Focus on activities that boost local growth

Future funding is subject to the Spending Review in April 26. Funding models will need to complement our devolution agenda and the government's five missions. We know that rural areas face different challenges and opportunities to enhance growth and prosperity and funding design will need to reflect those to enable place focused and place led solutions.

RMTG Focuses on Young People

Earlier this month, the Rural Market Towns Group (RMTG) held a sounding board session centred on the challenges and opportunities facing young people in rural communities. The session provided a platform for representatives from various market town councils to share their insights, discuss pressing issues, and highlight initiatives that are making a difference. The discussion was framed around three main topics: the biggest challenges facing young people, current initiatives and best practices, and desired policies for future support.



During the session, participants were asked to identify the three biggest issues facing young people in their communities. A common theme emerged around limited access to services and activities, leading to feelings of isolation and a lack of opportunities. The challenges have been exacerbated over the past three years by the impact of the COVID-19 pandemic, economic uncertainty, and changes in social behaviour. The sounding board highlighted several successful initiatives aimed at supporting young people in rural communities. These examples of best practices demonstrate how councils can make a tangible difference in the lives of their younger residents.

Soham Town Council Initiatives

Soham Town Council has undertaken several initiatives to enhance the recreational spaces available to young people. The expansion of the local skatepark is a key project, providing a dedicated space for outdoor activities. Additionally, the council has installed picnic units in the recreation ground, although they have faced challenges with vandalism. Despite these setbacks, the council is committed to improving these spaces, demonstrating perseverance in the face of adversity. The council is also working to bring back the Youth Connection Bus, a mobile youth service that offers support and activities, which was delayed due to a lack of drivers.

Cricklade Town Council, Wiltshire

Cricklade Town Council has made significant strides in providing safe spaces for young people. Responding to issues of anti-social behaviour, the council established a weekly session for 13-18-year-olds at a local leisure centre. This initiative, initially supported by a grant from the Wiltshire Council area board, is now fully funded by Cricklade Town Council. The sessions are facilitated by The Rise Trust, which provides youth work support across North Wiltshire. The council also supports an annual skateboarding event and a youth

festival, offering young people a chance to engage in new activities. These efforts have led to a reduction in anti-social behaviour and positive feedback from the community. https://rsnonline.org.uk/rmtg-share-your-best-practice...

Uppingham Youth Space

Uppingham Youth Space offers a weekly drop-in session for 11-16-year-olds, run by a local charity at the Town Hall. This project aims to improve mental health and wellbeing by providing a space where young people can socialise, participate in activities, and receive support. Despite challenges in securing funding due to the town's image of affluence, the charity has successfully obtained a five-year grant from the National Lottery Community Fund and additional support from local organisations. The project has been a lifeline for many young people, particularly those who do not participate in sports, offering them a safe and supportive environment.

The RMTG sounding board provided valuable insights into the challenges facing young people in rural communities and highlighted innovative initiatives that are making a difference. The session highlighted the importance of continued support, both through local initiatives and government policy, to ensure that rural young people have the opportunities they need to thrive. The examples shared, from Soham to Uppingham, demonstrate the resilience and creativity of rural communities in addressing these challenges, offering a model for others to follow.

WNC Planning Policy Meeting 18 September 2024

At the WNC Planning Policy Meeting on 18 September 2024, we considered the Council's response to the current Government consultation on Reforms to the National Planning Policy Framework (NPPF) and other changes to the planning system. Government has published tables identifying what the changes would be for each local authority - for West Northamptonshire, this would see the annual requirement increase from

2,124 to 2,584. For the current plan period (to 2041) this would increase numbers by 7,820 (17 x 460), assuming the base date of the Local Plan was moved from 1st April 2023 to 1st April 2024. The additional work required to meet this need will extend the period required to produce the plan and therefore the plan period will need to be extended. For every year extension there will be a requirement of a further 2,584 dwellings. For illustrative purposes an extension of two years would see a total additional requirement of approximately 13,000 dwellings. Planning officers warned that they will have to go back to the



drawing board to identify sites for the 8,000 additional homes required by 2041.

During the meeting, I said:

"According to the Rural Services Network (RSN) the NPPF proposes a 70% increase in Housing Targets in the Rural Areas and a 6% increase in Urban Areas. This brings a significant challenge to WNC to deliver Housing in the right place and of the right tenure". "There are a huge number of issues if we are to deliver housing that meets local needs outside of the planning system. We need to clearly identify the key issues for delivery in West Northamptonshire. Just saying we will increase the numbers by 13,000 dwellings won't just solve the problem. We need to get across to Government that planning is a critical factor but not the critical factor".

For WNC to comply with the new changes to the NPPF then there would need to be a thorough analysis of the shortfall of infrastructure to include roads, rural transport, schools, electricity, water, heating supply, hospitals and other medical facilities together with a report on green space with a view to creating buffer areas to prevent our village boundaries coalescing and avoiding ribbon development. Then we would need

to acquire this infrastructure ahead of any development. We cannot continue to ignore the existing deficit in essential infrastructure in our rural areas.

HOUSING

Transforming Housing Through 5 Year Funding Regimes

The Local Government Association (LGA) has published a comprehensive report, "Building a Better Future",

highlighting the critical economic and social advantages of implementing five-year housing funding regimes. This approach is positioned as a transformative solution to the enduring challenges of social housing



shortages, overcrowded living conditions, and homelessness across England.

A Call for Consistent Funding

For the past three decades, the growth in housing stock has lagged significantly behind demand. The current fragmented funding landscape, characterised by short-term, competitive funding pots, has led to inefficiencies and volatility in housing construction. The LGA report advocates for a shift to consistent, ringfenced funding allocated over five-year periods. Such a regime promises to stabilise housing construction efforts, streamline administrative processes, and ultimately deliver more social homes to those in need.

Economic and Social Benefits

The proposed five-year funding regime offers substantial economic and social benefits:

Increased Housing Supply: The certainty provided by secure, long-term funding is projected to lead to the construction of nearly 200,000 additional social homes over the next 30 years under current funding levels. With increased funding, this number could rise to almost 500,000 homes.

Financial Gains: The report estimates a net boost to public sector finances amounting to £3.3 billion over 30 years, potentially increasing to £5.6 billion with higher funding levels. These gains stem from reduced expenditures on temporary accommodation and homelessness services, as well as increased tax revenues from heightened construction activity.

Socioeconomic Impact: The construction of additional social homes is anticipated to generate socioeconomic benefits worth £31 billion, possibly reaching £56.1 billion with enhanced funding. These benefits include job creation, greater community stability, and improved living conditions for residents.

Tailored Local Solutions

One of the report's key recommendations is the devolution of housing funding and decision-making to local authorities. This would allow for more tailored and effective responses to the specific housing needs of different regions. By aligning housing strategies with local development plans and infrastructure projects, councils can ensure more cohesive and sustainable community growth.

In conclusion, LGA's "Building a Better Future" report makes a compelling case for the adoption of five-year housing funding regimes. By providing secure, long-term funding, local authorities can significantly enhance

their housing delivery capabilities, resulting in substantial economic, social, and financial benefits. This strategic shift promises to alleviate the housing crisis, improve living conditions, and foster stronger, more resilient communities across England.

Challenges and Constraints in Housing Supply

The Institute for Fiscal Studies (IFS) recently published a working paper on the determinants of local housing supply in England, shedding light on the underlying factors that contribute to regional disparities in housing availability.

The study estimates an average local housing supply elasticity of 0.14 over the period from 1996 to 2021,



indicating a limited responsiveness of housing supply to changes in demand. This is significantly lower compared to other countries like the US, France, and Germany. The low elasticity is attributed to several constraints including planning

policies, geographical factors, and land availability. In rural areas, these constraints are often more pronounced due to the preservation of agricultural land and protected natural areas.

The working paper identifies that areas with less land available for development, greater differences in elevation, higher historical population density, and stringent local planning authorities exhibit lower supply elasticities. Specifically, the share of land available for development and pre-existing urban density are highlighted as major determinants, accounting for 80% of the variation in local housing supply responses. In rural areas, the availability of developable land is often further constrained by agricultural use and protected land designations, such as Green Belts and national parks.

Rural areas face unique challenges in housing supply. The constraints of land use, combined with stringent planning policies, often limit the ability to develop new housing. This leads to increased housing prices and reduced availability, which can hinder economic growth and demographic diversity in rural communities. The working paper suggests that if rural areas had housing supply elasticities comparable to more flexible regions, they could better accommodate population growth and housing demand.

The analysis reveals stark regional differences in housing supply responses. London and other urban areas, despite significant demand, have a poor record of building homes where they are needed the most. Conversely, areas like the East of England, with fewer geographical constraints, show higher elasticity and better responsiveness to demand changes. Rural areas, particularly those with stringent land use policies and significant geographical constraints, exhibit some of the lowest supply elasticities.

The findings highlight the need for policy interventions tailored to the unique challenges of rural areas. Simplifying planning processes, increasing the availability of developable land, and re-evaluating land-use restrictions, particularly in rural regions, could enhance housing supply elasticity. Additionally, targeted policies to incentivize development in rural high-demand areas could help mitigate the housing shortage and promote sustainable rural communities.

The IFS working paper provides crucial insights into the factors limiting housing supply in England. Addressing these constraints is imperative for improving housing affordability and ensuring that homes are built where they are most needed. Policymakers must consider these findings to formulate effective housing strategies that align with regional demands and geographical realities, especially in rural settings.

Funding for Temporary Housing

WNC has approved a capital budget of £12.372 million to provide relocatable temporary accommodation

as part of our ongoing efforts to address the rising need for temporary housing in the area. The plan includes the delivery of around 100 units of relocatable temporary accommodation across two sites in Northampton, reducing the reliance on expensive and less stable options like nightly lets and bed and breakfast accommodation. The units - known as relocatable temporary accommodation (or reTA) - are designed to be genuinely relocatable, ensuring minimal regret costs and maximum flexibility. They will support



residents in securing stable addresses, which is essential for accessing employment and other opportunities and helping them transition back to conventional housing.

The project is estimated to save the Council approximately £667,000 annually by providing a more cost-effective alternative to current temporary housing solutions.

By providing stable and cost-effective housing solutions, we are not only addressing immediate needs but also laying the groundwork for long-term benefits for our community. This initiative underscores our dedication to improving the quality of life for our residents and ensuring that everyone has access to safe and appropriate housing. The Council has explored various strategies to tackle the housing crisis, including acquiring properties on the open market and increasing affordable housing delivery. However, the introduction of reTA is seen as a necessary and innovative step to complement these efforts and ensure adequate housing provision for those with an immediate housing need until a permanent accommodation solution is found. The project will also involve the development of housing management and support services to help residents prepare for a successful transition to permanent housing. Detailed planning and procurement processes will follow to ensure the efficient and effective implementation of the reTA units.

ENVIRONMENT

Joint Agency Flooding Update

Agencies are continuing to support Billing Aquadrome's management with their evacuation plan whilst it



remains temporarily closed due to flooding and with further flood warnings in place. Around 28 people and 5 pets stayed at the rest centre overnight and were provided with emergency bedding, toiletries and hot food and drink and supported by community volunteers from the British Red Cross and Re: Act and WNC staff. A further 21 people and their pets left the centre having planned to stay with family and friends. All agencies including the Fire Service, Police and Environment Agency are continually assessing the conditions at the site and the ongoing weather however with more rainfall expected, a

flood warning remains in place for the site. Having ordered the evacuation of the site, the park's management is working with electricians, plumbers and other contractors with a view to ensuring preparations are made to move people back once the flooding risks have passed and it is safe to do so.

Water levels across the area remain very high, with flood warnings currently in place on the River Nene at Billing and Cogenhoe to Great Doddington, as well as the River Tove at Towcester and Cosgrove and low-lying areas close to the River Great Ouse and River Ouzel at Newport Pagnell.

Further Progress on Sustainability Efforts

WNC has continued to make progress in its sustainability journey by retaining a national environmental



accreditation. We are pleased to have retained the Bronze Award accreditation with the

Investors in the Environment scheme (iiE) following an independent audit, showing our commitment to reducing our environmental impact. iiE is a national environmental accreditation scheme designed to help organisations save time and money, reduce their impact on the environment, and get recognition for their progress.

As a Council, we have worked to improve on the foundations put in place to achieve the bronze

award for the first-time last year. Over the past 12 months, this has included:

- 1) Publishing our first Sustainability Report, setting out priorities against the UN Sustainable Development Goals
- 2) Focussing on embedding sustainable thinking into all our job roles, projects, and policies rather than it being looked at as an addition to or adaptation.
- 3) Continuing to grow a sustainability staff network and councillors net zero action group to guide, influence and involve communities, colleagues, and partners.
- 4) Refreshing the online Sustainable West Northamptonshire information hub and social media channels to promote, share and encourage good practice.
- 5) Actively supporting staff with additional training, including members of the Sustainability Team undergoing a Pathways to Net Zero course.
- 6) Consulting the public on a draft electric vehicle infrastructure strategy that will be published in early 2025 to support the increase in EVs.
- 7) Participating in the national No Mow May campaign for the first time, leaving areas of green spaces to grow naturally in a bid to increase biodiversity.

We are dedicated to making changes that will have a positive impact on the environment and the lives of our residents, to make a difference today and in the future. We are taking steps in the right direction and are keen to continue building on the work that has already been done.

Update on Severe Weather from WNC

The stormy conditions have put extreme pressure on the road network, causing localised flooding and overwhelming ditches and brooks due to the rapid and intense rainfall not able to drain away fast enough across the system.

Highways response teams for Kier and West Northamptonshire Council have been out and about supporting emergency services, having attended 200 incidents during the recent flooding, three quarters of which were flooding related with the remainder a mix of emergencies, such as fallen trees and dislodged/broken manhole covers.


At the last meeting on 23 September 2024, we reviewed the LAP progress over the last month, details as follows:

Children & Young People (CYP)

Towcester had come onto the radar due to an individual having links with a Birmingham gang, B4. In addition, at the Schools Contextual Safeguarding meeting they raised concerns that Anti-Social Behaviour (ASB) had increased significantly over the last few months and there were concerns this would further increase over the summer whilst schools had no oversight. Child Exploitation Risk Assessment Framework (CERAF) forms had been completed where appropriate. A Task & Finish group was brought together to better understand the issue and seek some solutions.



- There is some ASB on the Rec and down through the brook area to the back of the leisure centre. A group of 'Not in Education, Employment or Training' (NEET) young people was the catalyst.
- There was an Incident related to the County Lines issue where some young people were chased.
- Young people are gathering in the Water Meadows drinking, smoking weed and swimming in the weir.
- There is a core group of young people not currently in education who would not engage with regular youth clubs or sports activities.
- Parents need support/advice/awareness of grooming and gang issues.



 Vandalism/desecration of graves/anti-social behaviour at the Cemetery took place in the early hours of Sunday 4th August 2024. Towcester Town Council has asked the SN Policing Team to include Towcester Cemetery in its regular patrols due to ongoing issues with anti-social behaviour and threatening/intimidating behaviour over the past 12 months or so. However, there is a concern that local Police do not have sufficient resources to allocate resources to this.



Guiding Young Minds (GYM) Intervention is a confidential service that strives to establish credible, life-altering relationships with vulnerable Children and Young People through delivery of a specialist, holistic service. The GYM bus attended Towcester on the following dates:

- a) Mon 5, 19, August
- b) Thurs 8, 15, 22, 29 August

SNYE fun day on 30 August was a good opportunity to engage with young people. At the Rec/Brook area and Water meadows



there are increased patrols and Park Ranger patrols at Water meadows.

Inspector Johnny Davis-Lyons is putting on a week of action and looking at the probability of a date in late October. The following activities scheduled by the Serious Violence Prevention Team in November are.

Dementia Support

Women Over 50 Returning to Work

We are starting a project within the Rural LAPs to support women over 50 re-entering employment. This will align with the Governments 'Returnership' program. A 'returnership' is a new offer which brings



together three programmes to help get older workers back to work. These Apprenticeships, Skills Bootcamps and Sector-Based Work Academy **Programmes** (SWAPs). 'Returnerships' will raise awareness of these pathways, providing a clear route back into work and encouraging employers to hire older workers. David Yarnall discussed the services offered. For the next year up to April 2025, we have funding where we can help with social isolation and get people back into employment. There are different

coordinators who can specialise in different skills. We will be getting Adult Learning into the Rural East to provide residents with more opportunities. These would be free of charge. It will make a positive difference to social cohesion and isolation, as well as educate the community to return into employment. Dates are now being firmed up with all parties to design a scheme of work and commence delivery.

Carers

Northamptonshire Carers are embarking on a roadshow of one stop shops across all LAP areas to offer

information, advice, and guidance to unpaid carers. Theses one stop shops are funded by the Accelerated Reform Fund and will include: an informal café style area staffed by Carer Support Workers and Volunteers, information about Northamptonshire Carers and the services we provide with the option to register with Northamptonshire Carers should they wish to do so, IT equipment and a printer for carers to use to complete forms, blue badge applications etc, a private room for pre booked carers assessments to take place and



each one stop shop will include a form of holistic therapy i.e. hand massage.

Our aim is to be as accessible as possible to unpaid carers, bringing information and advice more rural areas of the county as well as out towns. We are yet to confirm a venue for the Rural East.

Social Isolation- Bereavement

Our Social Prescribing Link Workers (SPLWs) have expressed a concern that there is a gap in support for those suffering from bereavement and grief. They mentioned that there is a feeling that 8/10 referrals for loneliness are a result of bereavement. WNC are in the process of drafting a business case for the pop-up Grief cafes – The Good Grief Trust. Our aim is to utilise the Welcoming Spaces to host these pop-ups. The long-term goal is to empower communities to sustain and manage these groups from within.



The impact on the residents will be support and companionship during times of bereavement and loneliness. We are currently in early conversations and seeking funding.

Towcester Health and Wellbeing Strategy

We have been working with Parish and Town Councils to create health and wellbeing strategies and to maximise their impact in promoting health and wellbeing for their communities. We have met with Towcester Town Council and provided data and insight which supports this. The key strengths and weaknesses of the parish were created from an AI summary of the full local insight data report. The data itself is very comprehensive. This was used to give an overview during our meeting of the priority areas for Towcester. We are all working together to co-produce a comprehensive strategy. A large Community Centre is being built within the new housing development. There is an opportunity to add groups and events within this space.

Economic Growth Plans

Working together with Samantha Hoskings, Brackley & Towcester Town Manager, we are looking to implement a programme of work to energise the High Street. Our aim is to identify and develop areas which could provide 'pop-up' retail areas for local entrepreneur and SMEs. We are planning to work with Business and IP Centre (BIPC) to support this project.

To give an overview, the BIPC is delivered via the Northamptonshire Library service and offers several free business support resources including workshops, webinars, 1-2-1 support and access to business information / market research databases. The BIPC Northamptonshire's new Build Your Business Programme may also be able to support business's with a £2,000 grant. They can also talk with you about the basic principles of intellectual property (IP) and how these might relate to protecting your business.

Young Enterprise

Following on from the highly successful 2-day delivery of the business and life skills at EWS, Roade Campus which comprised of.

- Fully funded delivery agreed for whole of year 8 from both EWS Campus` to take part in a business skills workshop.
- The aim is to grow workplace skills, confidence, finance, presenting, problemsolving real-life scenarios.

This presents a valuable chance to influence the school curriculum to reflect the needs of the local community.



A second workshop is planned for the Deanshanger Campus in the Autumn term.

Community Connect

The Community Connect project was recently launched to improve the wellbeing and welfare services in West Northants. Recognising the value of partnerships, we are working together to maximise the impact of Community connect and our commitment is to connect individuals with essential advice and support. We know that by collaborating we can create a stronger, more resilient community and our community connects advisers are trained in various aspects of health, social care, and welfare, which enables them to



provide top notch support and advice to those in need. Our annual goal is to support, advise and assist around 300 individuals within the community and since April we have already signposted, referred, or directly assisted 78 people which includes 10 families who were in urgent need of access to food and other necessary resources. The community connect

team are out and about at various welcoming spaces, they are also using our minibus to go out to the rural villages to try and encourage and enable the community members there to approach them with their concerns. We also recently launched our club, which is where we are facilitating opportunities for our most vulnerable and isolated members to participate in various activities throughout the year. This helps to give them a sense of connection to their communities while also combating social and rural isolation and helps to promote the active engagement. So far, we've run three activities which have positive feedback and has prompted a demand for additional activities, which help to enhance community connections. The initiative also motivated members to explore new experiences which they may not have tried before, and they said

that it has really improved their sense of well-being and their desire to do more socialising now that they are able to increase their confidence coming out of the COVID pandemic.

From a volunteering point, we've had more than 500 volunteers participating in various community initiatives. These individuals have dedicated their time and effort to assist members with needs of their local community. They make a substantial contribution and make a greater impact through the work that they've been engaged with. Some of the projects they've been involved with have been the maintenance of the grounds at Towcester church and Greens Norton Church, as well as the decoration of two storage rooms at Towcester Primary School, which will be used as chill out areas for students with special educational needs. Finally, on to the healthy active ageing, which is what we're now calling the reducing health inequalities in older population project. Last Wednesday, we presented to over 120 community members aged 65 and over about ways in which they can live a healthy and active life. We discussed in depth the concept of health inequalities and explored various ways in which we could address them within our local community using the local assets that we have available to us. We agreed that by fostering collaboration, communication, and coordination we can engage others so that together we can ensure that everyone within our community is living a healthy and active life. We've got more community conversations to have. These will be completed by the beginning of August and once we've got all the findings from these community conversations, we will be producing a report that will enable us to plan a strategy on how you can reduce those health inequalities in Brackley.

Partner Updates

Police update

Sergeant Lorna Clarke gave the following update:

Immediate justice is the latest government push to get offenders for low level offences completing essential community service. They provide four hours of work back into the community and we've got a



team of people who will coordinate this. The initiative takes a low-level offence like criminal damage, common assaults, other things that the Police are dealing with, and then refers them to get an out of court disposal and refer them to the immediate justice team. The Police are looking for work for them to do in South Northamptonshire. They are gradually getting themselves set up. It must be public place it cannot be a private place. They are looking for projects now, the officers have also got to put the offenders into referral.

They are looking at fly tipping and things that are going on in

this LAP. They have all their own transport, fully independent and government funded. It is a pilot project but they're looking to roll it out from October 2024. We are a pilot force and they're looking to push it out to all other forces. They've got new people in the team. Sergeant Lorna Clarke updated that we're struggling with South Northamptonshire volume of offenders. They have focused their efforts on Northampton because they have a big volume of crime turnover there and it's working well. They are gradually finding their feet there and they are trying to spread out to South Northamptonshire.

GP update

Dr Philip Stevens gave an update on PML. PML is a not-for-profit healthcare provider delivering NHS primary healthcare contracts in Oxfordshire and Northamptonshire. "We have been conscious of patients accessing urgent care and we had a presentation from NGH Urgent care, Chris Pallot at the health and wellbeing board and there was a relative lack of information about what it's going to do for Daventry and South

Northants in their county wide plan". He admitted for the rural area, we should develop a plan which we can share as part of the project. This has been done, and at the present time the GP Federation are going



round the practises to look at capacity, both in terms of manpower and in facilities to see what we can develop. The county is meant to have based it on population size between eight and nine urgent care centres and of course we've got one. The idea is there are these urgent care centres, maybe run by paramedics or nurses with medical backup to save people having to go to A&E for assessment and treatment. Principal medical run the urgent care centre some reports inside said it is exceptionally busy until 11:00 o'clock at night. It's been very successful in looking to extend it initially to 2 o'clock in the

morning and then all night. In terms of financial modelling, the Northamptonshire system is grossly overspent.

Dr Philip Stevens had discussions with the Northampton Borough GPs about how we can put a bid together with them to cover the whole area. It's early days, the whole process will take the rest of this year and that is the way the care work is going anyway for the ICS. So, we're looking to have hubs in Daventry, Towcester and Brackley. There will be savings in A&E and to take the pressure off A&E of NGH. We are looking to expand it so we're looking to do it on a basis which is cost neutral at best.

Jackie Power introduced herself to the LAP. She works for PML, Parkwood, which is Denton, Wootton and the parks surgeries, including Grange Park and Blisworth. Anyone in the GP surgery or any member of primary care, or mental health can refer patients. Patients can self-refer. They can spend more time on non-medical issues. So, people can be referred with issues such as low-level anxiety, social isolation, bereavement and benefits, financial stuff. Social prescribers run well-being groups in collaboration with

adult learning and Northamptonshire sport. They have set up a coffee

morning in Hackleton.

24-Hour Mental Health Text Message Service Launched

Northamptonshire Integrated Care Board (ICB) along with North and West Northamptonshire Councils have partnered with charity Mental Health Innovations to offer free, confidential and 24/7 mental health support to those across the county through the charity's text messaging support service Shout.



been funded The partnership has through North and West Northamptonshire Public Health services and ICB to provide this innovative digital offer for anyone in Northamptonshire to enable them to access 24-hour mental health support, 365 days a year from their mobile phone. The service launched on Monday 2 September and people in the county can text the word 'IMATTER' to 85258 to be connected to a trained Shout Volunteer. The service is open around the clock and can help with issues

such as anxiety, stress, loneliness, depression and suicidal thoughts. The conversation, which takes place entirely by text message, aims to help the texter reach a calmer place with a plan to move forward. It will also signpost them to further support available locally.

Shout is a free, confidential and anonymous service, designed to provide people with in-the-moment support. Texting Shout does not appear on phone bills and all messages are confidential unless there is concern about someone's safety. Shout is available and free in the United Kingdom.

Vaccination for Pregnant Women & Unborn Child

Pregnant women across West Northamptonshire are being encouraged to take up the free flu vaccine offer ahead of the winter months. Pregnant women, and their unborn child, are at a higher risk of complications and more severe conditions such as pneumonia, as the immune system naturally weakens during pregnancy. Flu can also affect the growth of their baby, which could lead to still birth. There is a higher risk of pregnant women being admitted to hospital due to flu than the general population.



In 2023-2024 64% of pregnant women, in West Northamptonshire did not get vaccinated against flu, increasing the likeliness of them catching the seasonal flu infection. This year, West Northamptonshire Public Health are encouraging pregnant women to get vaccinated as soon as they can. We are starting to see an increase in respiratory infections within the community and with the colder weather there will be more mixing and movement indoors, which will lead to an increase in the spread of all viruses, including flu. It is, therefore, important that those who are pregnant get vaccinated as soon as possible.

It is also encouraged that women take up other vaccinations offered whilst they are pregnant, including Whooping Cough (Pertussis), so they and their unborn child are protected against vaccine preventative infections. Send School to Create an Extra 230 Places

The delivery of the new 230-place school in Tiffield, Northamptonshire, has reached a significant milestone. Following the demolition and clearance of the site, which took place this spring, the steelwork for the school is now complete.

Being built on St Johns Road, on the former St Johns Centre site, the construction project is being led by national contractor Willmott Dixon for West Northamptonshire Council, Greenwood Academies Trust and the Department



for Education. The new school will provide additional special educational needs and disabilities (SEND) spaces in the local community.


Set to complete in Summer 2025, the specialist school will improve access to education and increase the support available to families. Pupils aged four to 18 years old will benefit from a variety of facilities including specialist teaching spaces, a soft playroom, a sensory room and a rebound therapy room.

A playground, outdoor soft and hard play areas, and staff and visitor car parking are also included within the plans. A drop-off area and additional queuing space will also be available, making drop-off and collection easier for pupils and parents. Due to the rural landscape surrounding the school, landscaping has been prioritised on the 20,217sqm site to ensure the school blends in with the surrounding area. Joining Willmott Dixon on the project team are Associated Architects, Hexa Consulting, JEH Planning, Ares Landscape Architects and SVM Building Services Design.

ECONOMIC DEVELOPMENT & GRANT FUNDING

WNC Awarded £1.4m for Skills and to Grow Economy

West Northamptonshire Council (WNC) has awarded £1.4 million in grant funding to a wide range of projects, including 24 community organisations to support initiatives focused on enhancing local skills, addressing critical needs, and fostering positive change within the community. Funded by the UK Shared Prosperity Fund (UKSPF), the People and Skills Grant funding is designed to empower individuals and grassroots organisations by providing the resources needed to cultivate essential skills and foster a resilient workforce equipped to meet evolving needs and drive economic growth. The largest part of the skills programme is an initiative called "Skills for Communities", providing community organisations with funding to deliver innovative skills projects. The successful grant recipients were selected through a competitive process based on their innovative approaches and potential for significant community impact. The funded projects cover a wide range of areas, including Not in Education; Employment or Training (NEET); Digital Literacy, Science Technology Engineering Maths (STEM), English Speakers of Other Languages (ESOL) Literacy at Work; and inclusive recruitment.



Support on offer will include one to one personalised coaching to help people get back into work, help for families in crisis, increased volunteering opportunities, therapeutic sessions to support adults' mental health and emotional wellbeing, and a programme to tackle social exclusion in young people. The primary objectives of the People and Skills Grant Funding program include:

- Enhancing Workforce Skills and providing targeted training programs to help individuals acquire
 new competencies and advance their career and employment prospects, such as Digital and
 Literacy Skills in the Workplace.
- Promoting Inclusivity by ensuring equitable access to skill development opportunities for underrepresented and disadvantaged groups, such as those for whom English is a second language (ESOL) or those looking to improve their levels of Literacy at Work.
- Supporting Innovation and encouraging the development of innovative solutions to address current

and future skill needs, such as STEM Skills.

Strengthening Community Resilience and building a robust and adaptable workforce that can thrive
in a rapidly changing economic landscape, focusing on supporting individuals recovering from longterm health challenges or those leaving care to engage with employment opportunities and
training.

Construction Works Underway for New Shopping District

The works on Fish Street, as part of a wider regeneration project to Northampton town centre, are well underway with new lettering cementing the rejuvenation of this part of the town. West Northamptonshire Council is working with Kier Transportation to carry out vital works to enhance



the appearance of Abington Street and Fish Street. Since March, nearly 900m2 of paving has been installed on Fish Street, along with an improved drainage system and fish themed paving designs. This project will lift the quality of the public spaces through high quality materials, increasing seating and planting, introducing new art and play opportunities along the street, as well as space for outdoor dining and community activity.

Businesses in the area have been kept up to date with the project's phases, and the project's dedicated single point of contact has been working closely to ensure they have been able to operate with minimal disruption. The redevelopment will complement the wider Market Square transformation and provide enhanced connectivity with the rest of the town. Work continues with the completion of Abington Street repaving, the upgrade and installation of street lighting, installation of street furniture, planting of new trees, and minor finishing touches. Waspi Women Supported

WNC has supported a campaign calling for women adversely impacted by changes to the state pension age

to be compensated. Tens of thousands of women in Northamptonshire were among millions affected by a government decision in 1995 to increase the state pension age from 60 to 65, and again to 66 in 2012. The Women Against State Pension Inequality (Waspi) group wants women to be compensated over the government's failure to tell them - or provide adequate notice - about the changes.

A motion to support the campaign was unanimously supported at a meeting of West Northamptonshire Council last week.

Earlier this year, the Parliamentary and Health Service Ombudsman (PHSO) found communications from the Department for Work and Pensions (DWP) on the age increase were flawed.

A DWP spokesperson said: "This was a serious report, requiring serious consideration. "We will continue to listen respectfully to the women involved and ensure we take on board any lessons learnt."

All 68 members at Friday's meeting voted in favour of alerting Northamptonshire's newly elected members of parliament and pushing for compensation.

TRANSPORT & HIGHWAYS

Traffic Enforcement Rules

Motorists who continue to flout road restrictions in three busy areas of Northampton now face immediate fines for doing so, under enforcement measures to help keep traffic moving there. In February this year, West Northamptonshire Council (WNC) started to enforce the hatched yellow box at the junction of St John's Street and Victoria Gardens, as well as no Right turns allowed from Fishponds Road into Great Billing Way and the bus only route at Hermitage Way.

The measures were put in place to help reduce traffic congestion after the Department for Transport (DfT)



changed legislation to enable local authorities to apply for powers to enforce against moving traffic contraventions. During the first six months of enforcement measures going live, a warning notice was issued for first offences to any vehicle, however from 1 August (St John's Street) and 16 August (Fishponds Road and Hermitage Way) onwards, anyone who has breached the rules at these sites has received a Penalty Charge Notice (PCN) of £70, reduced to £35 if paid within 21 days. Deanshanger Road went live on

10 June so warning notices are still being issued to motorists for their first occasion breach only.

During August, 796 motorists received immediate PCNs across the three sites:

- St John's Street Box Junction 415 PCNs
- No right turns from Fishponds Road into Great Billing Way 316 PCNs
- Hermitage Way bus only route 65 PCNs

Community Transport Set to Expand

A community transport service which provides a lifeline to its users is expanding its fleet thanks to funding from West Northamptonshire Council (WNC).

Towcester-based Ability was awarded a £477,181 grant by West Northamptonshire Council, out of the



Government's Rural England Prosperity Fund (REPF) and UK Shared Prosperity Fund (UKSPF).

The community transport provider has used the money to buy four new minibuses, increasing the size of its fleet to 14 vehicles and allowing the service to reach even more people and places across the West Northamptonshire area.

The not-for-profit Community Interest Company has so far taken delivery of two Mercedes-Benz Sprinters, and officially launched them at an event at the Council's offices at The Forum in Towcester this week. The two new vehicles will soon be joined by

two Mercedes Cityliners. It's all a far cry from Ability's humble beginnings in 2018, when Directors Lynn and Nigel Hinch raised money for a single minibus with the aim of helping to reduce isolation and loneliness for those without access to public transport, or who might otherwise struggle to get out and about.

Today the organisation operates a wide range of on-demand bus services across West Northamptonshire, linking villages and towns via regular routes as well as taking people on shopping trips and outings, and even offering door-to-door transport for those who need it.

Ability's impact on the communities it serves was recently celebrated by BBC Radio Northampton, who awarded the service the Great Neighbour Award in its Make a Difference Awards 2024.

Ability is one of seven community transport operators to receive money from a £951,000 pot set up by West Northamptonshire Council thanks to the REPF and UKSPF funds. In Ability's case, the majority came from REPF. Brackley Volunteer Car Scheme, Cogenhoe & Whiston Parish Council's Village Hopper service, the Comm Minibus, Daventry Area Community Transport, Northampton Door to Door and Towcester Area Door to Door all also benefited from a share of the funds.

Road Safety Fund

Supported by the Northamptonshire Safer Roads Alliance (NSRA), grants of between £500 and £5,000 are available for initiatives that support road safety priorities. This includes speed reduction, anti-social road

use, drink or drug driving, educational initiatives that lead to positive behavioural change on the roads, and projects that improve road safety near schools.

Since the start of the 2024/25 financial year in April, this grant pot has awarded nearly £60,000 to local parish councils and schools to improve road safety. This has helped fund both the purchase and installation of vehicle activated speed signs, signage and various other traffic calming measures.

Serious Violence Partnership Awards

Northamptonshire Serious Violence Prevention Partnership (NSVPP), has awarded £68,642 to Family Support Link, supporting the expansion of the Northamptonshire Parents under Pressure program (PuP). The NSVPP first supported the program in 2023 and this new award extends the program to support additional families with complex needs, including parental substance abuse and children either currently



engaged with child protection or those who are at imminent risk of going into care. It focuses on working with the parents to develop emotional regulation skills, confidence and be emotionally supportive so they can support their children in developing their own self-regulation.

The expansion of the programme will target early intervention within families that have high risk factors for becoming involved in serious violence. This project is a part of the NSVPP's proactive public health

approach to serious violence, aiming to not just tackling the problem but preventing its occurrence.

It will help protect children and young people from experiencing adverse childhood experiences while building resilience and other protective factors. Addressing these challenges reduces the potential for children to become involved in a life of crime, violence and drugs.

Northamptonshire Serious Violence Prevention Partnership (NSVPP), formally NSVA, was formed in 2023 to tackle serious violence in Northamptonshire. The partnership includes Northamptonshire police, Northamptonshire Fire and Rescue Service, Youth Offending and Probation Services, Northamptonshire

Integrated Care Board, North Northamptonshire Council, West Northamptonshire Council with the Northamptonshire Police, Fire and Crime Commissioner. The NSVPP aims to stabilise and reduce serious violence, and to understand the underlying causes of violence in the county. Their focus will be on preventing violence from occurring because it is not inevitable but preventable.

Immediate Justice Having Positive Impact

More than 100 people have been referred to a scheme helping to repair the damage they have caused to local communities by anti-social behaviour. The Immediate Justice Team, which sits within the Office of the Northamptonshire Police, Fire and Crime Commissioner, has helped to facilitate more than 380 hours of community improvement work across the county since December 2023.



This work has been carried out by people who have been

referred to the scheme by Police Officers and PCSOs after committing offences such as criminal damage, being drunk and disorderly, harassment and causing a public nuisance. The Immediate Justice scheme sees those who have carried out low-level crimes swiftly and visibly pay for the damage they have caused. People who have been dealt with, carry out reparative work such as litter picking, removing graffiti, and repairing public property, instead of being charged through the courts for their crimes.

Of 108 referrals to the Immediate Justice programme:

- Seventy-nine have completed their penalty, with a further sixteen pending.
- Nearly two thirds were referred to the scheme because of drug possession.
- Most people to take part were men.
- Most were aged between 18 and 24.
- Thirteen have refused to take part and will be referred to the arresting officer.

Starting from mid-September, young people aged between 13-17 can now also be referred to the service

and complete community improvement work.

Park's New Mountain Bikes for You to Try Cycling

Twenty new mountain bikes have been donated to Northampton Bike Park by West Northamptonshire Council (WNC). The bikes,



together with a set of 20 helmets, will allow more people the opportunity to try mountain biking without the commitment of buying a bike. They have been gifted to the park as part of the Council's partnership with British Cycling — a two-year initiative funded by the UK Shared Prosperity Funding (UKSPF) with the aim of encouraging more people to ride and making cycling more accessible for everyone. The partnership recently saw West Northamptonshire successfully host a stage of the men's Tour of Britain race when one of the competitors was Tom Pidcock, who won Olympic gold for Team GB in the men's cross-country mountain bike race in Paris over the summer. Communities across West Northamptonshire came out to show their support for the Tour recently and were hopefully bitten by the cycling bug. We're delighted to

be able to gift these bikes to provide an opportunity for people who may not have previously been able to use the park to come along and enjoy all the benefits it has to offer.

Opened in September 2022, Northampton Bike Park is a joint project between WNC and Northamptonshire Sport and features a multi-user green trail, off-road mountain bike trails of varying difficulties, plus climb sections and a skills area. Situated on the site of the old Delapre golf course, the Park is well connected to the local cycle network, town centre and neighbouring housing areas, including the Norbital, National Cycle Route 6, and is accessible to people of all ages and abilities.

Cycling is a great way to be active and the donation of the bikes is a step forward in helping even more people to enjoy the bike park and the trails. We run a programme of courses for beginners to the sport, being able to offer a bike as part of the package opens the opportunity to try Mountain Biking without the commitment of buying a bike. The donation also means we can invite local schools and community groups to come and try the facilities in pre-arranged visits.

Guest Curators can be individuals, groups, or societies proposing an object for inclusion. No prior historical knowledge or expertise is required, and the objects can represent any period of Northamptonshire's history, from ancient times to the present day.
